### Primary energy use

The primary energy use for this property per year is 219 kilowatt hours per square metre (kWh/m<sup>2</sup>).

### Environmental impact of this property

This property's potential CO<sub>2</sub> production is 3.9 tonnes of CO<sub>2</sub> per year.

One of the biggest contributors to climate change is carbon dioxide (CO<sub>2</sub>). The energy used for heating, lighting and power in our homes produces over a quarter of the UK's CO<sub>2</sub> emissions.
