Situation:- Callington is a small town with a population of around 6,500 people and is situated in the heart of Southeast Cornwall, around 15 miles from the City of Plymouth. The 4 Bedroom detached bungalow is deceptively spacious and occupies a generous size plot, situated with a popular residential location with level walking to all local amenities. The property offers so much potential for growth and would benefit from updating. The front access is at the side of the property with the rear access at the opposite side. There is a hallway to which all the rooms lead off. There is a generous lounge and formal dining room offering ample space. The kitchen/utility would make an ideal open plan kitchen/breakfast and a doorway gives access out to the side. There are two shower rooms with one allowing space for a bath to be re-installed. There are 4 bedrooms with potential for a 5th. The property benefits from gas central heating and uPVC double glazing.

## OUTSIDE

The property occupies a generous size plot. Access is via a shared driveway which leads to the detached garage. To the front of the property is a level garden enclosed with walling and hedging being mainly laid to lawn. The gravelled driveway leads to the garage and continues across the front of the property offering ample parking. The front and rear access is to each side of the property. Both pathways continue to the rear of the property. The garden at the rear is a generous size and enclosed with shrub hedging. Being fully laid to lawn it offers ample room for keeping small animals if required. There are uninterrupted countryside views toward Caradon Hill to be enjoyed.

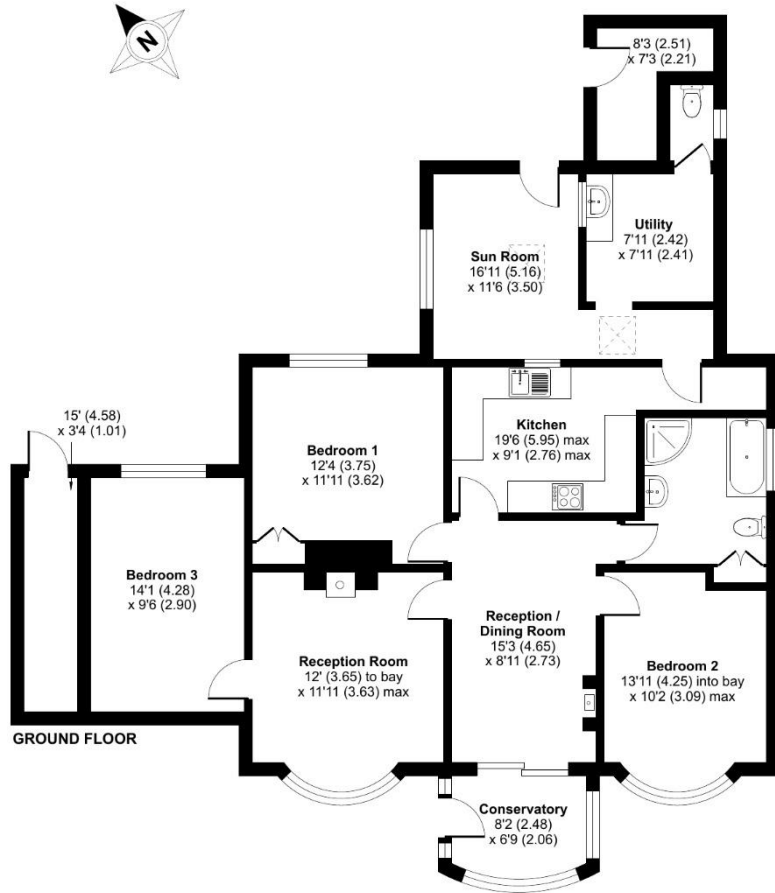
