### Location

Marshland St James is located approximately 7 miles from the centre of King's Lynn and approximately 5 miles from the centre of Wishech

Watlington Station is approximately 6 miles away, with direct links to King's Lynn, Cambridge and London King's Cross.

Wisbech is an attractive and historic market town commonly known as the Capital of the Fens.

King's Lynn has a direct rail link to Kings Cross via Cambridge in approximately 1 hour 40 minutes.

Downham Market, approximately 8.6 miles away, is one of Norfolk's oldest market towns and has a good range of shops, a busy market on Fridays and Saturdays and a main line railway station to King's Lynn, Cambridge, and London Kings Cross.



## **Description**

Middle Drove Enterprise Park consists of a variety of industrial and storage units set in a secure gated environment. There is communal parking located centrally within the site, which provides ample additional car spaces.

Much of this versatile storage yard has a hard standing surface with a strip of level concrete through the middle.

The area is bounded by security fencing on three sides with gated access to the entire site directly off Middle Drive Road, providing excellent security 24/7.
