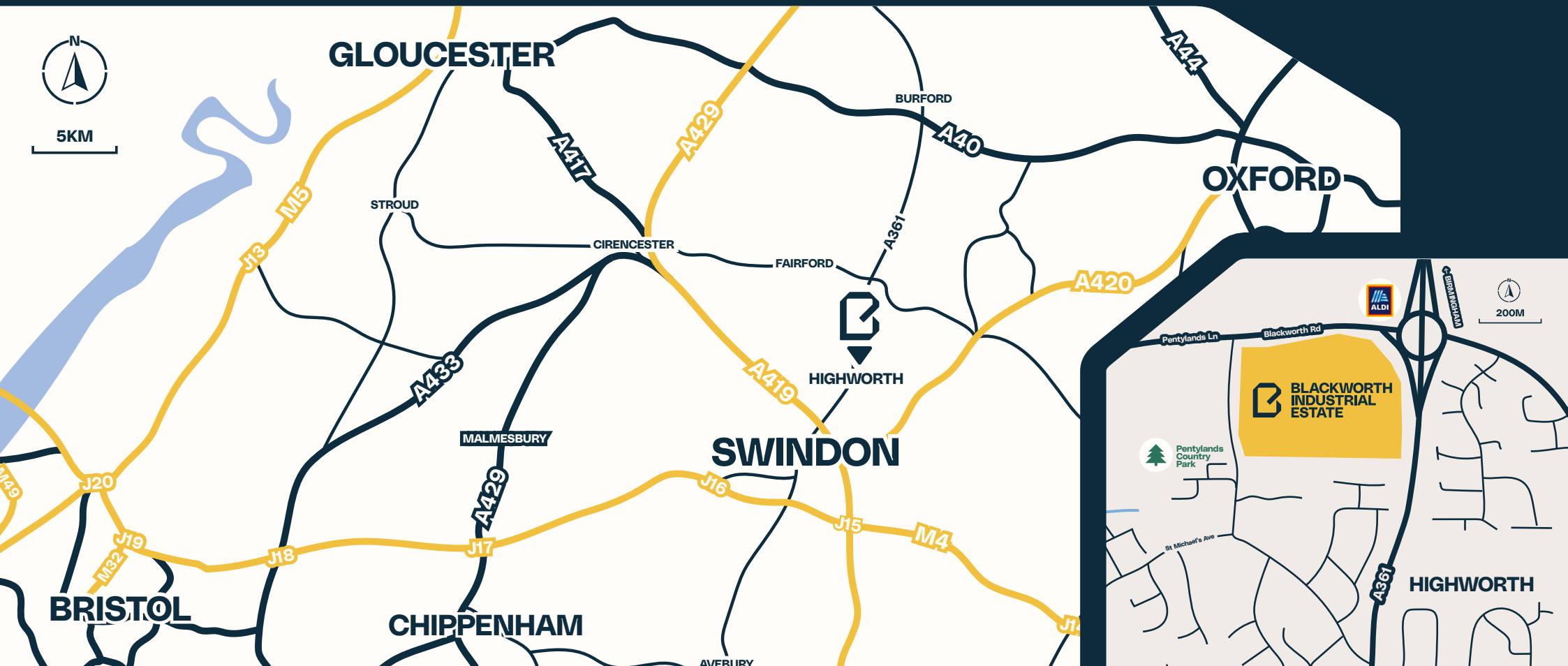
LOCATION

The premises are located at Blackworth Industrial Estate, the principal employment area in Highworth, to the north east of Swindon. Direct road access is provided onto the A361 Lechlade Road, which in turn connects to the A419 trunk road, 4 miles to the south west.

Swindon is the largest town in Wiltshire and is well served by the M4 (Junctions 15 and 16) linking Reading and London to the east and Bristol to the west.

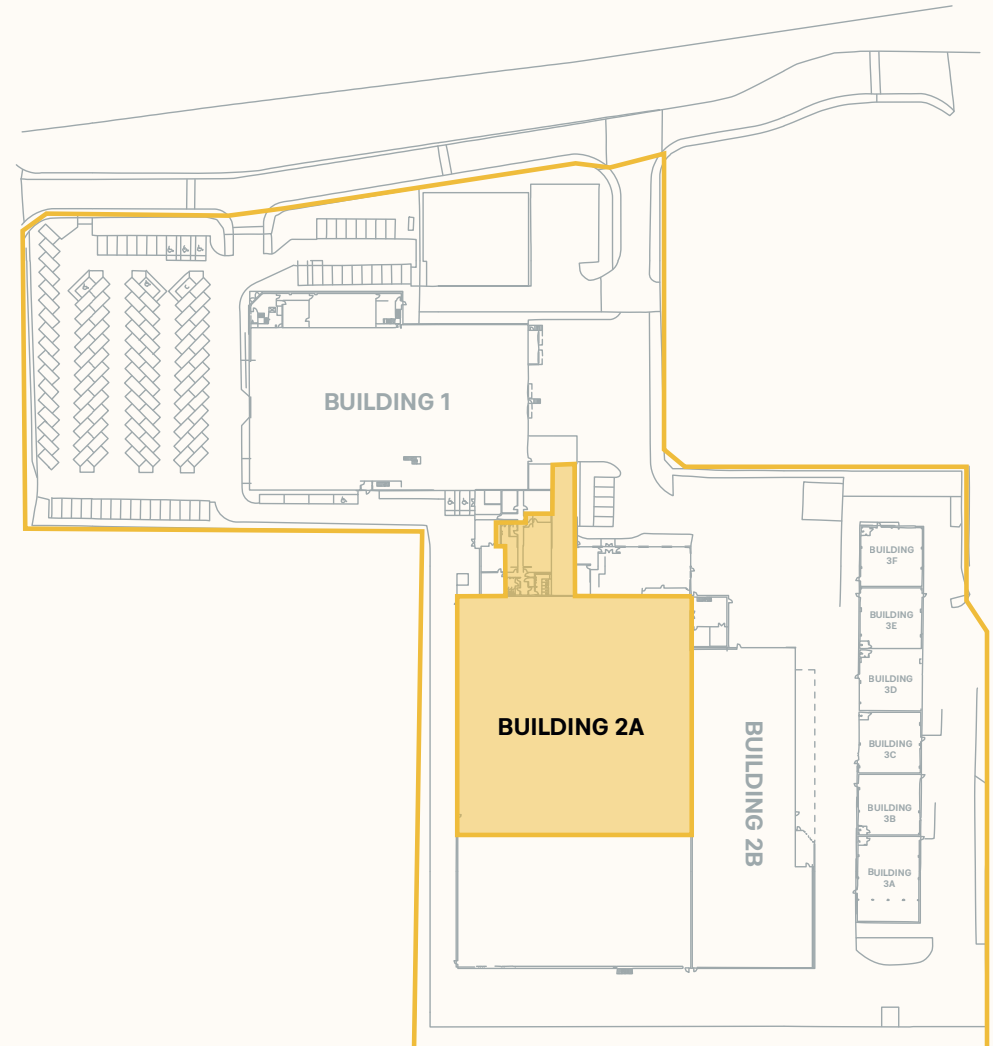
The refurbishment works have now completed and the unit is available for immediate occupation.
