Bedroom three is of double proportions located to the rear with dual aspect windows, pastel decor.


Bedroom four is a further double located to the front of the property, pretty decor, decorative coving, picture rail.

To the rear is a large garden with established shrubbery, shingled seating area, pergola, large expanse of lawn, mature tree, patio area.


