LOCATION

The site is located in the heart of Cranfield diagonally opposite the church of St Peter and St Paul. Cranfield has a range of village facilities including two public houses, two small supermarkets, a post office and a number of takeaway restaurants. In addition, there is a doctors' surgery, dental practice and pharmacy. A number of recreational facilities include two parks and a multi-use games area. Local schools include Cranfield Church of England Academy, Holywell Middle school, Wootton Upper School and Bedford Harpur Trust Schools.

DESCRIPTION

The site comprises the side garden to The Rectory. The site has a frontage to Rectory Lane of some 19.5m/64ft and an average plot depth of 36.5m /120ft, giving a site area of 0.079 hectare / 0.195 acre or thereabouts. The land is relatively level, but with a steep bank up to the proposed new western boundary with The Rectory. The northern and southern site boundaries are defined by brick walls, the eastern boundary by close boarded fencing. Access would be via a new driveway from Rectory Lane, subject to planning permission and highway consent.

PLANNING

The site offers potential for development with a single dwelling or a pair of dwellings, subject to planning permission and any other necessary consents. Local planning authority: Central Bedfordshire Council: 0300 300 8307

SERVICES

Mains drainage, water, electricity and gas supplies are available within the vicinity of the site. None of the services have been tested and prospective buyers should make their own enquiries of the relevant authorities.

TENURE

The property is for sale freehold, with vacant possession to be granted on completion.

METHOD OF SALE

The property is offered for sale by private treaty, on a subject to planning basis. Prospective buyers are invited to submit offer, subject to contract and planning, supported by a sketch scheme indicating how they envisage the site would be developed. The successful bidder may enter into a conditional contract or an Option Agreement on terms to be agreed.

The sale will be is made subject to the following covenants:

- Not to submit a planning application other than in accordance with plans previously approved by the Seller
- Not to develop the site other than in accordance with the plans approved by the Seller
- Not to extend or alter externally the properties to be built other than in accordance with plans previously approved in writing by the Seller
- Not to cause nuisance to the occupiers of The Rectory
- Not to use any property other than for residential use in the occupation of a single family
- Not to carry out any commercial activities from the property (save that a professional use ancillary to the residential occupation of a dwelling is permitted)
- To erect within 3 months of completion, and thereafter maintain, a 1.8m high treated timber close boarded fence between points A-B on the plan
