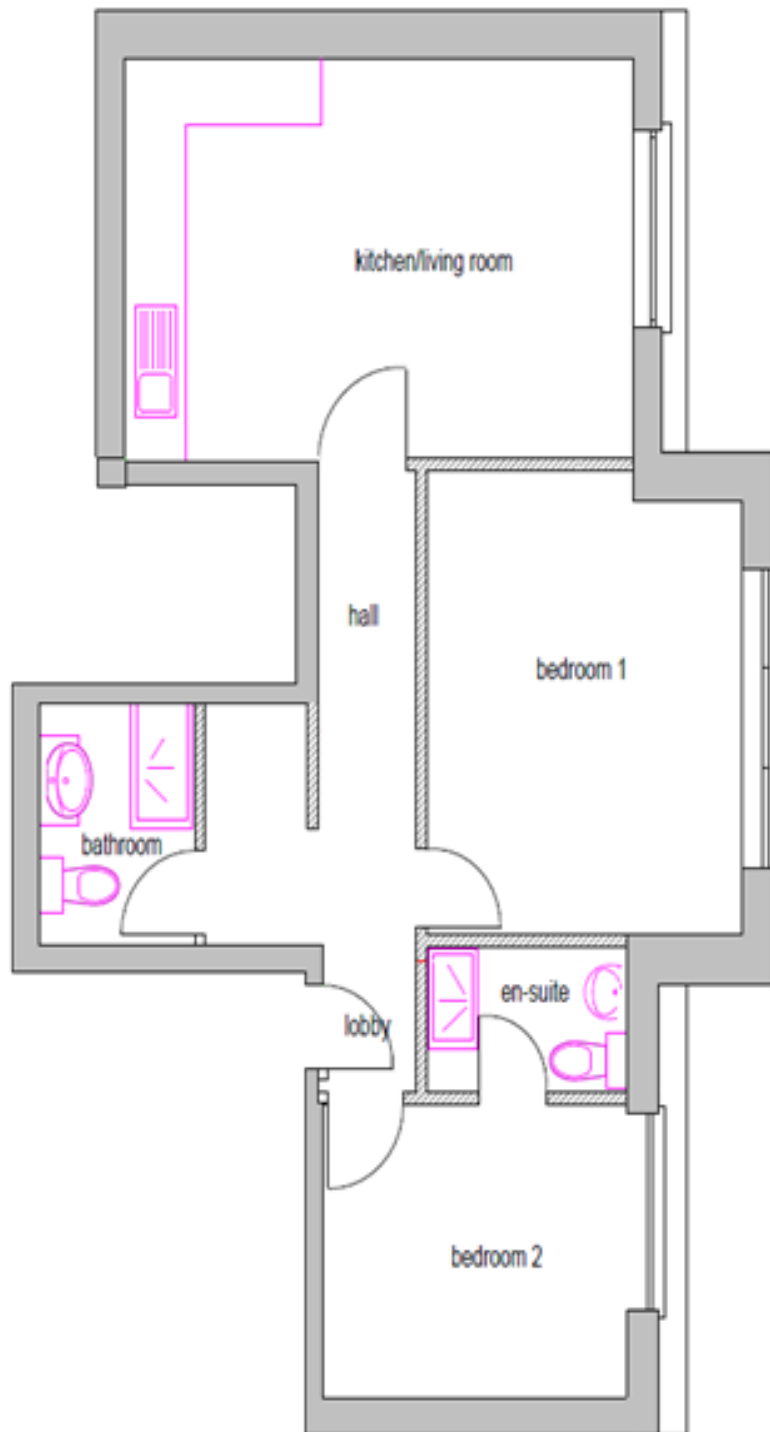

| Holding Deposit (per tenancy) | One week's rent. This is to reserve a property.
