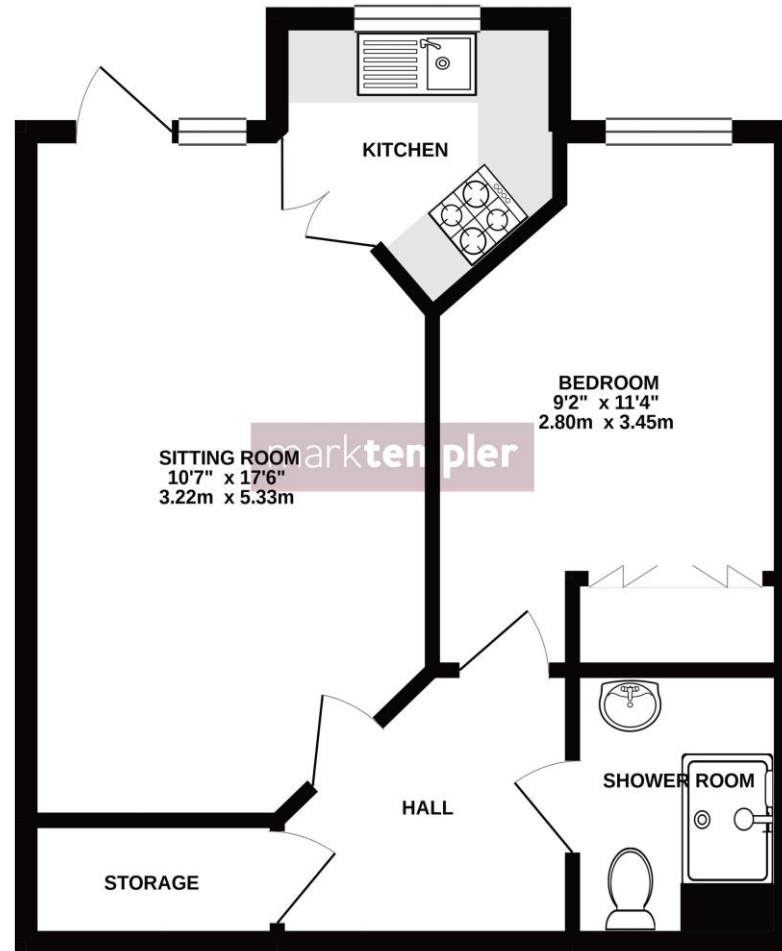
The building offers the upmost of convenience being a very short walk to Clevedon Town Centre, Curzon Cinema and Lidl Supermarket.
