LOCATION

Capel Close is located on the Fairwood Industrial Park which is on the west side of Ashford, having access on to the M20 motorway at Junction 9 about 1.5 miles away. Ashford town centre is within walking distance of about a quarter of a mile. This is an established and busy industrial estate, having a variety of trade counter type users.

Ashford, one of Kent's designated growth centres, currently has a population of approximately 75,000 inhabitants and is set to grow substantially in the next 20 years. The town is centrally located within the county, benefitting from a fine communications network via the A20/M20 and five mainline railways. Ashford International Passenger station gives direct access to northern continental Europe via Eurostar and London is some 38 minutes distant via HS-1.

DESCRIPTION

This end-terraced industrial unit of steel portal framed construction provides a little under 3,000 sq.ft. of accommodation. There is a minimum eaves height of 20'4", rising to a maximum of 24' 1" at the apex. The premises were constructed in the 1990s to a very high standard and are of concrete block construction to a height of some 8 feet, with micro-rib, profiled insulated steel cladding to upper elevations and roof.

Externally there is a generous yard area for loading/unloading and vehicle parking.

ACCOMMODATION

Workshop/Warehouse 2,820 sq.ft. including WC.

SERVICES

All main services including a 3-phase electrical supply are connected to the premises.

BUSINESS RATES
