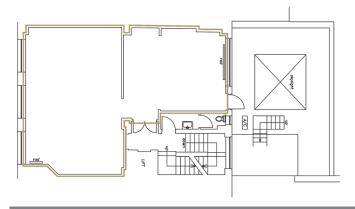

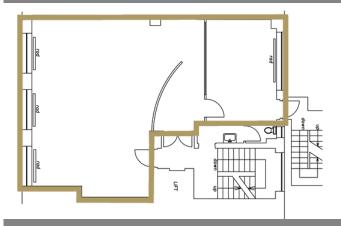
FLOOR PLANS

Not to scale.

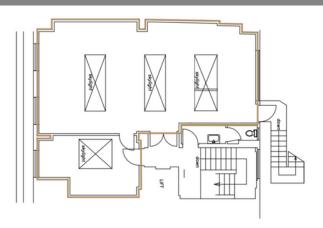
First Floor 810 SQFT / 75 SQM
