The Property

A well-located storage site in Gillingham has become available.

Situation

Gillingham is a North Dorset town that has expanded rapidly in recent years due to its convenient location. The town benefits from a main line railway station, Waitrose, Asda and various schools. Brickfields Industrial Estate is a relatively large industrial estate situated on the south-west side of the town (and south of the railway line that dissects the town). Home to Dextra Group among others.

Directions

Gillingham is conveniently situated between Shaftesbury on the A30 and Wincanton on the A303 and has decent road links between the two. The property is accessed from the south of the town (the Shaftesbury road) via the B3081 (New Road) after the rail bridge. Access to the site is first right after the bend in the road and the site is on the right after approximately 200m.
