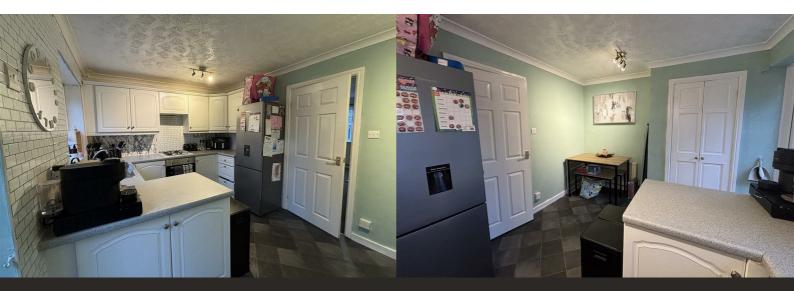

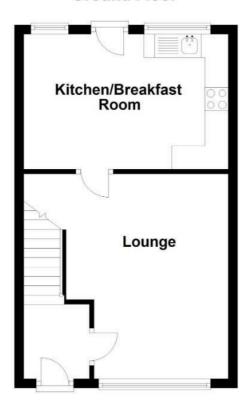


Floor Plan

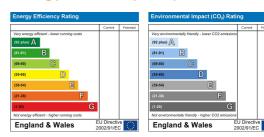
