From Shrewsbury proceed to Montford Bridge along the B4380 road. Turn right in the village and travel a short distance to Forton, taking the first turning left to Little Ness. Follow this road for just over 2 miles to a crossroads. Proceed straight over and up the bank to the village, turning first right and then first left. Follow this lane a short distance and the entrance to the development will be seen on the left with the property being on the left hand side.

SITUATION

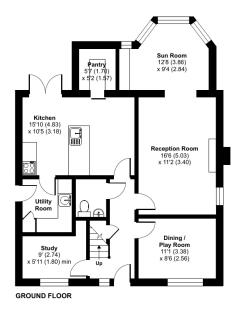
The property occupies a lovely position on the fringe ofthis sought after village, offering partial views from the first floor accommodation over open farmland. The village is particularly well known for its unspoilt surroundings with country lanes providing walking opportunities. The neighbouring village of Baschurch offers a good range of facilities including a Co-op shop, repair garages, pubs, tennis and bowling clubs together with the popular Corbett school. There are a good selection of schools locally including private and state. Commuters will find there is ready access both south and north to Shrewsbury and Oswestry, with further connections through to Chester or Telford.

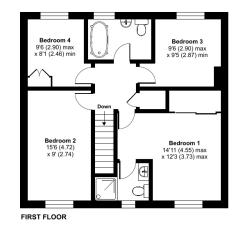
PROPERTY

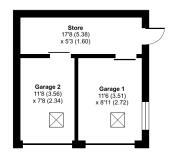
The property offers an excellent opportunity to purchase such a tastefully improved family house, which is finished to a particularly high standard and offers a versatile living environment.

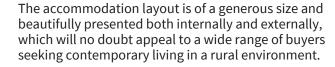

On the ground floor there is the kitchen/breakfast room with a large pantry and doors leading to the rear patio and alfresco entertaining area. There is also a downstairs WC and utility room.

The large double sitting room is a particular feature as it has views over the gardens, a log burning stove and two areas, one more formal for entertaining and one for relaxing. To complete the ground floor accommodation there is a well proportioned dining room and study.

On the first floor there are four bedrooms, one en-suite and a family bathroom.











OUTSIDE

Outside the property is approached by a private driveway. There is a good sized private parking area to the front and wrap around gardens with lawned areas and patio areas to the rear. There is a double garage that has been converted to offer a multi-functional home office/games room and could even potentially be used as an annex with some further work.
