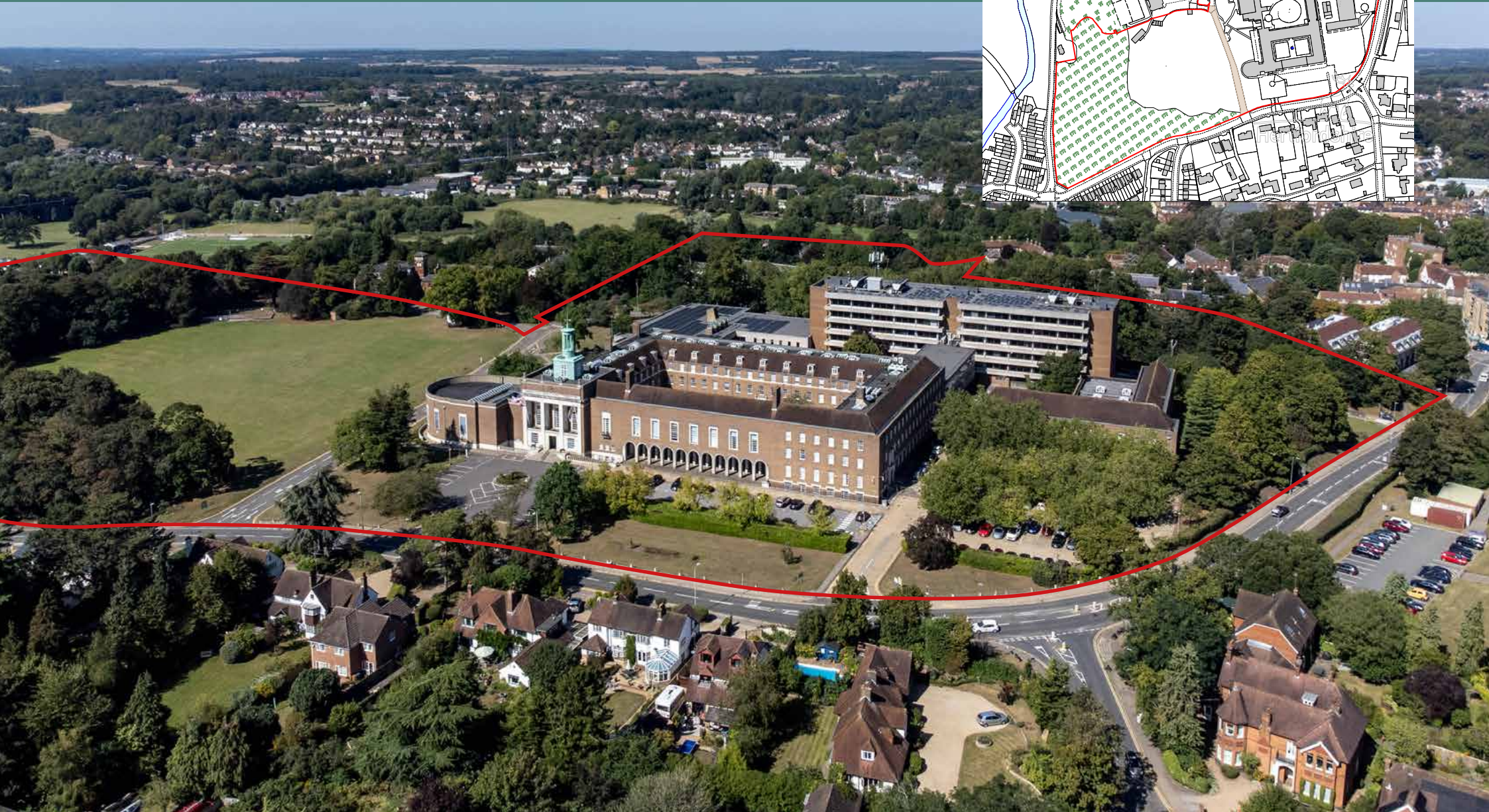
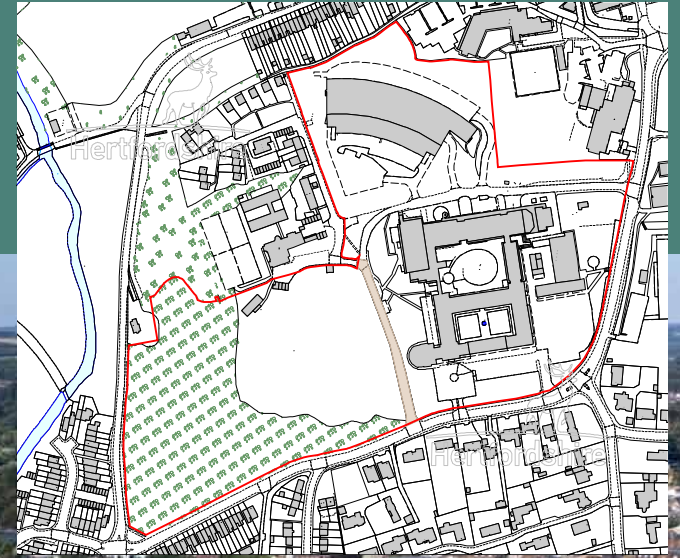

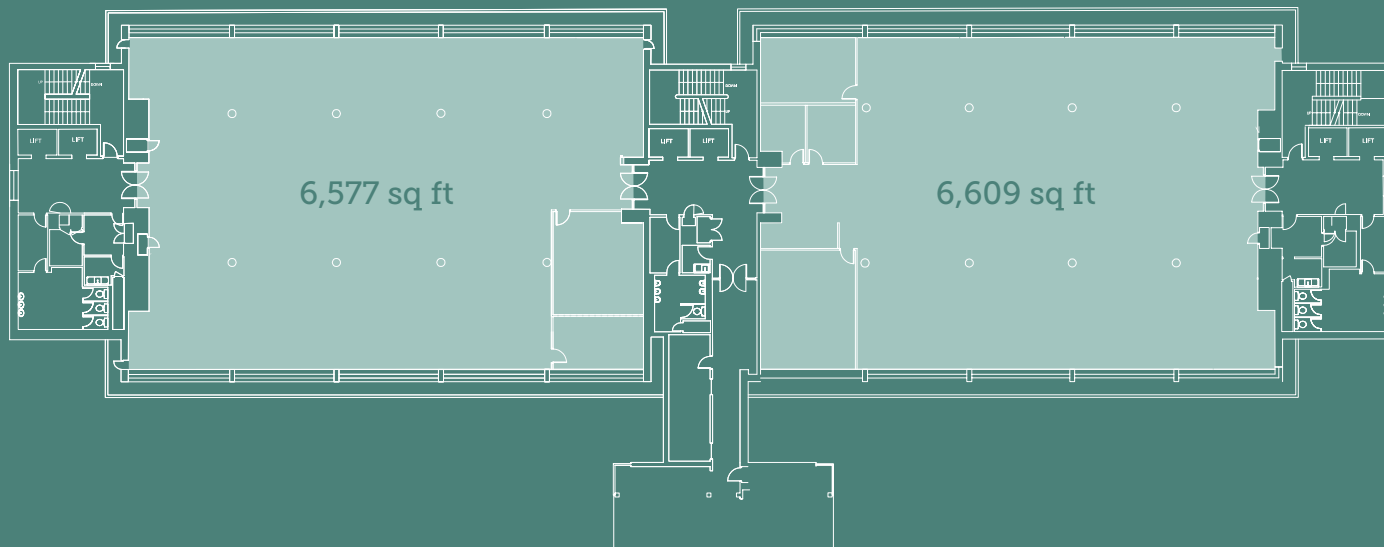

Location

Hertford is a thriving, vibrant town. Its centre is home to an array of independent retailers, high street stores, delis, cafes and coffee shops. The area boasts a variety of sports facilities and places of historical interest to visit, all nestled in beautiful countryside just 20 miles from London.



Communications

Situated just 20 miles from London, Hertford has excellent transport links to London from its two stations with trains arriving from the capital every fifteen minutes.

Hertford East Station has a half hourly service from London Liverpool Street and Hertford North station is on the Letchworth Garden City line served from Moorgate with a journey time of approximately 40 minutes.

The town's bus station provides routes around Hertfordshire, to Harlow and Stansted (via Harlow) and Heathrow Airports.
