LOCATION

The property is situated on College Green, in the heart of Bristol City Centre, adjacent to the Royal Bristol Marriott Hotel and close to the intersection of Park Street and Anchor Road.

The property is located within a short walk of the city centre Bus Station, and approximately 15-20 minutes from Bristol Temple Meads Railway Station which provides local and national rail links.

The property backs onto the harbourside, where there are a host of restaurants and bars, coffee shops, a cinema and museums, and where there are often markets and events held.

DESCRIPTION

The property comprises a Grade II Listed office building and is situated in the College Green Conservation Area. The accommodation is configured over three upper floors, and benefiting additional basement storage.

The property is due to be fully refurbished to provide predominantly open plan accommodation with a specification to include new carpeting throughout, perimeter power points, LED lighting, and gas central heating. The property also boasts a number of features to include coving, ceiling roses, wall panelling, and timber sash windows providing views onto College Green

CAR PARKING

There are two allocated car parking spaces located in the Royal Bristol Marriott undercroft car park.
