The property is situated in Bristol in a Harbourside location.

DESCRIPTION

The property is configured as a predominantly open plan unit with glazed frontage and front entrance. The unit is currently fitted out as a hair salon, with LED lighting, hair wash area, cutting area and WC facilities and kitchen/staff room.
