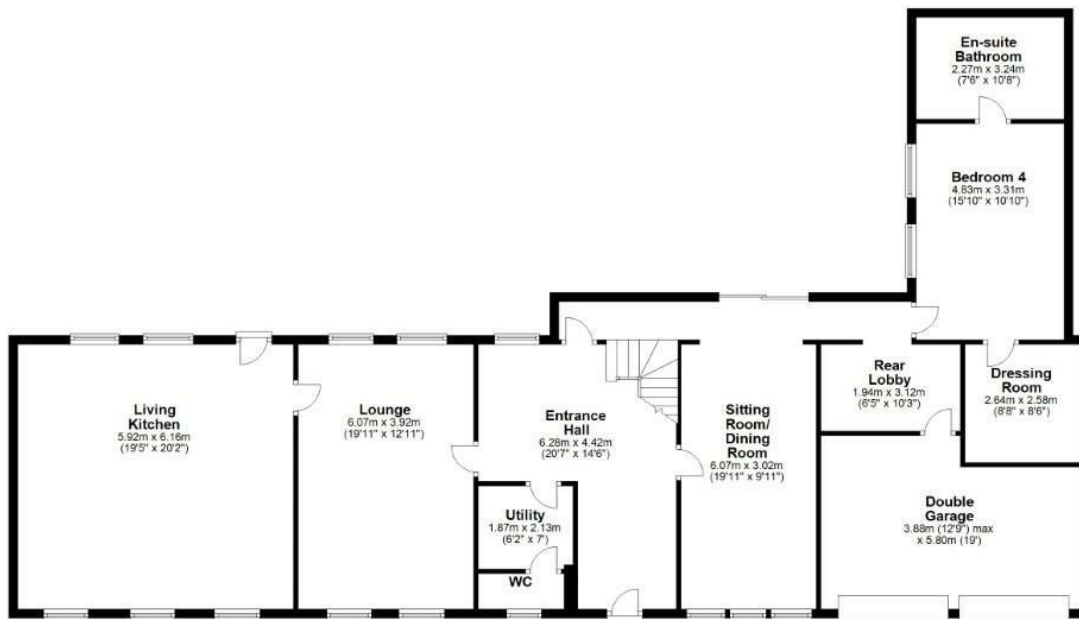

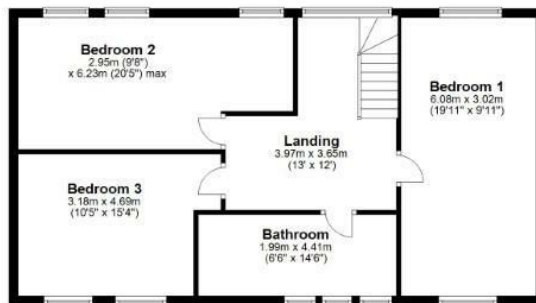

Approx. 71.1 sq. metres (765.7 sq. feet)

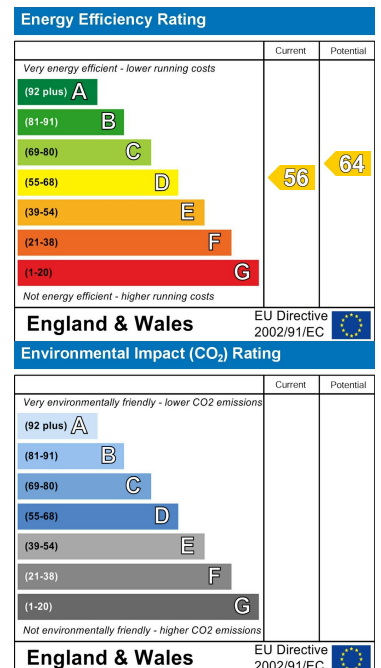
