Entrance Vestibule

Enter the property through a wooden front door into the entrance vestibule. There is access to the living room and staircase rises to the first floor.

Living Room

To the front of the property is a carpeted spacious living room with a gas fire sitting within a tiled fireplace with an oak hearth making for an ideal focal point. A large PVCu to the front aspect of the property.

Kitchen

To the rear of the property is a laminate floored kitchen with matching wooden wall and base units and tiled splashbacks. There is a stainless steel sink and drainer and three free standing spaces for appliances. There is a PVCu window to the rear aspect as well as a brand new composite door leading to the rear garden. Access to the cellar.

Cellar

Stairs lead to the cellar which provides excellent storage and benefits from electric and plumbing.

Carpeted stairs lead to first floor accommodation. Access to both bedrooms and the house bathroom.

Bedroom One

A very spacious double bedroom to the front of the property. Two wooden windows to the front aspect of the property allowing plenty of natural light.

A second double bedroom to the rear of the property. A wood window to the rear elevation.

House Bathroom

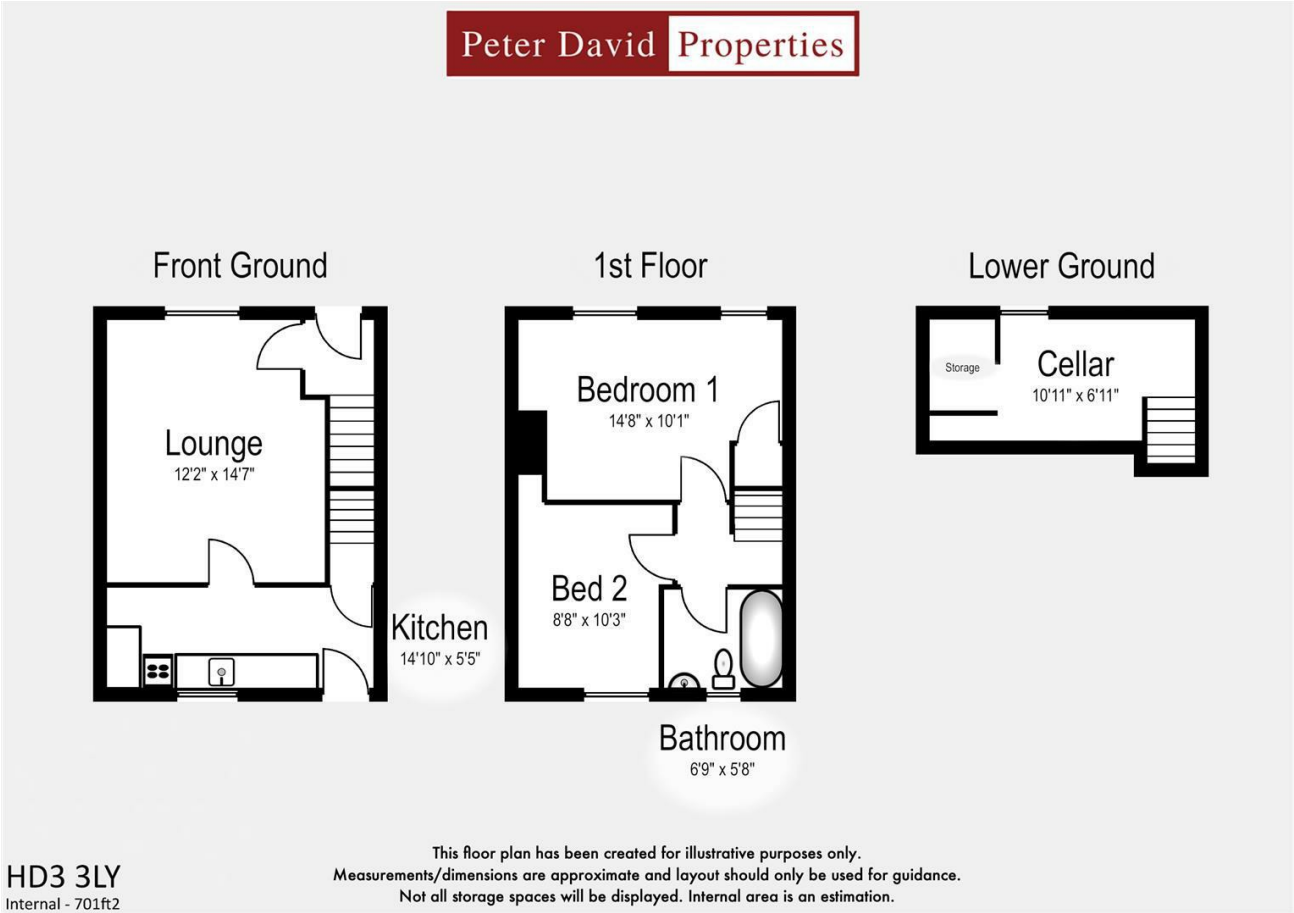
Hybrid Map



Terrain Map



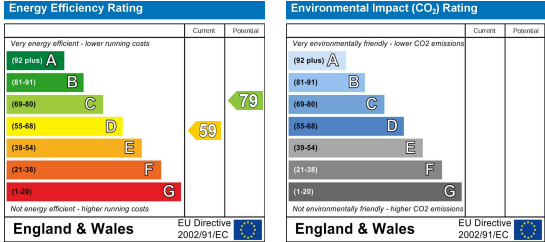
Floor Plan
