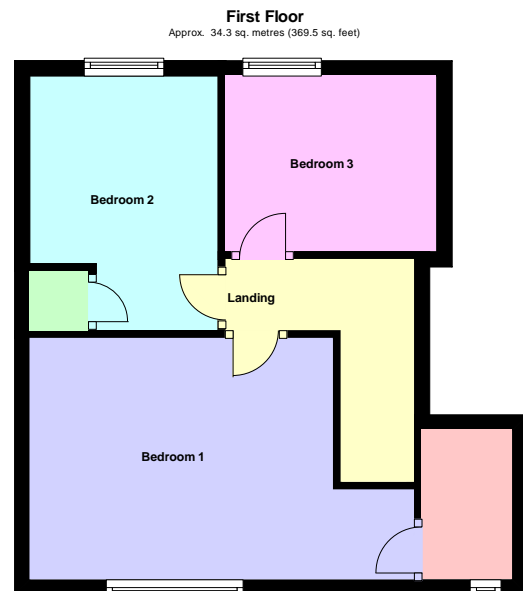
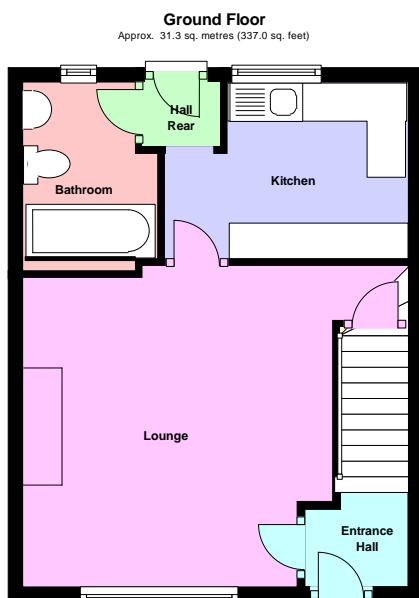

Available for immediate possession is this three bedroom terrace property which benefits from uPVC double glazing, gas radiator central heating, a refitted kitchen and a rear garden exceeding 60ft in length.
