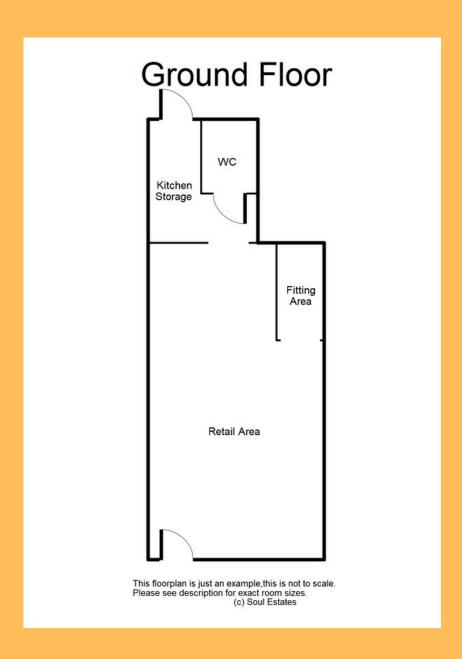








FLOOR PLANS:
