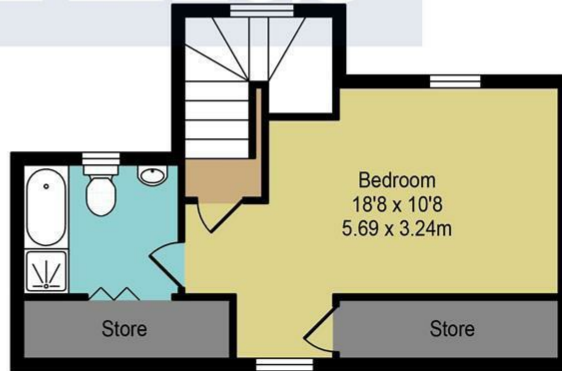

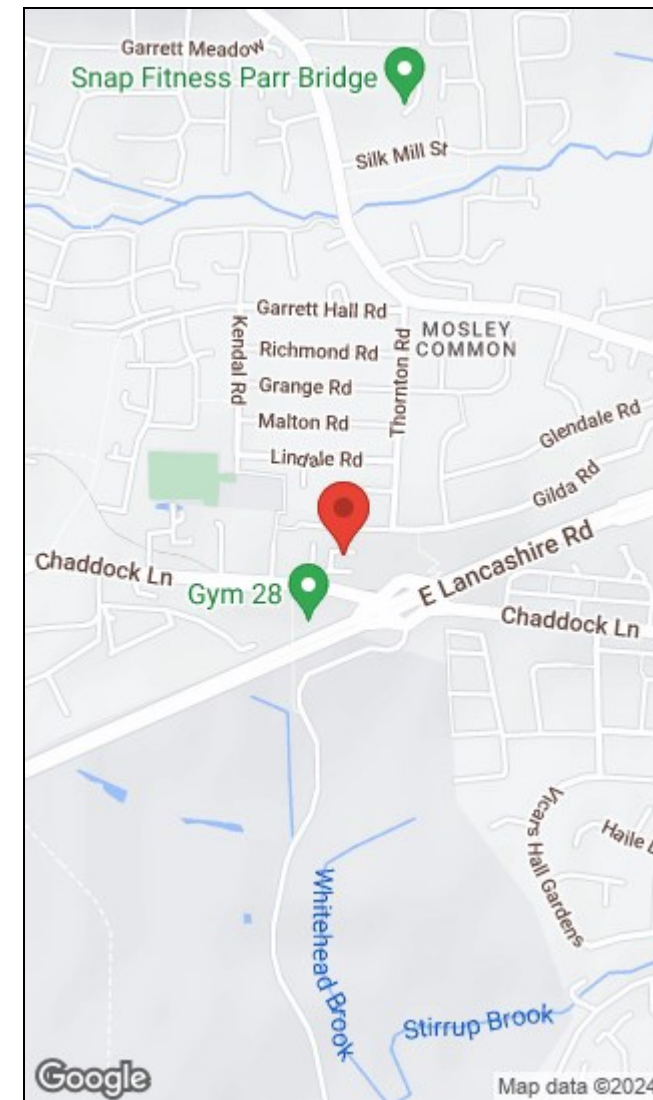
First Floor
