### **DESCRIPTION**

End of terrace industrial to let. Constructed of steel portal frame with brick and insulated cladding to elevations under an insulated profiled metal clad roof with skylights providing good natural light.

The unit has a pedestrian access door and a roller shutter door to front with a height of 4.25m and a width of 2.91m.

The inside provides a warehouse measuring 7.10m  $\times$  6.78m with concrete floor, alarm system, single phase electricity, disabled WC, a kitchenette and stairs to first floor wooden mezzanine of 7.09m  $\times$  2.24m. The unit has LED lighting. The height under the mezzanine is 2.59m.

The minimum eaves height in the warehouse is 5.88m and the maximum is 7.43m.

Outside to front there is parking for 2/3 vehicles.


