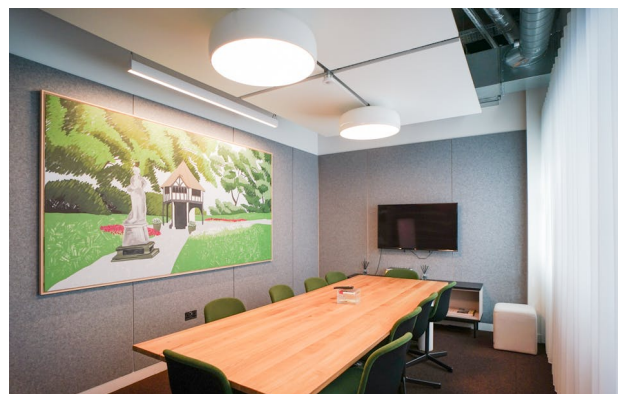
Location

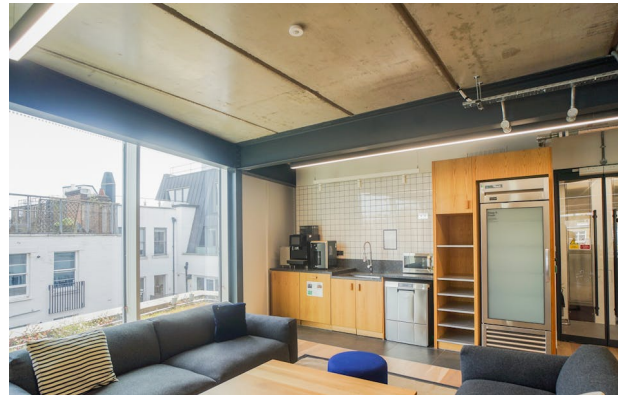
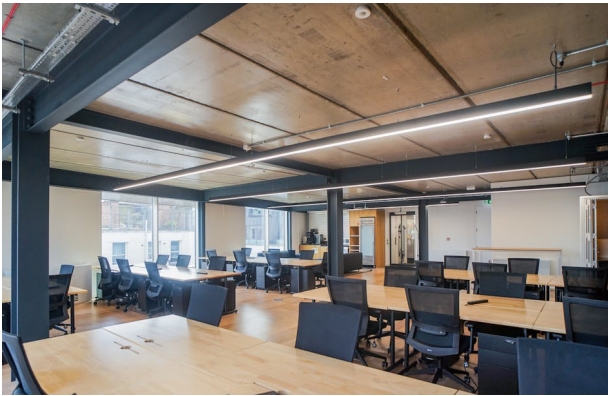
