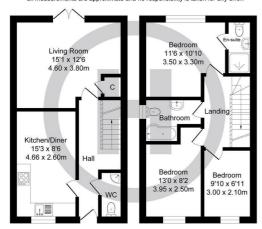




## Floor Plan

# Stothert Street Total Approx. Floor Area 852 Sq.ft. (79.2 Sq.M.)

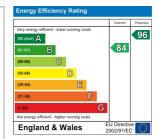

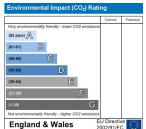


Ground Floor
