#### Entrance Hall

The entrance hall has Amtico flooring, a radiator, a NEST digital thermostat, an in-built double door cupboard, carpeted stairs, and a single composite door providing access into the accommodation.

This space has a low level dual flush WC, a pedestal wash basin, Amtico flooring, partially tiled walls, a radiator, recessed spotlights, and an extractor fan.

#### Reception Room

This versatile room has a UPVC double-glazed bay window to the front elevation, Amtico flooring, and a vertical radiator.

The kitchen has a range of litted handleless base and wall units with Quartz worktops, decorative tiled splashback with LED lighting and recessed spotlights, a central breakfast bar island, an undermount sink and a half with a Quooker mixer tap and draining grooves, an integrated Siemens oven, steamer oven and combi microwave oven, an integrated Siemens coffee machine, a Bora induction hob with a downward extractor fan, an integrated fridge freezer, an integrated dishwasher, an integrated wine fridge, space for a dining table, two vertical radiators, tiled flooring, a UPVC double-glazed bay window to the front elevation, and a bi-folding door opening out to the rear garden.

The utility room has fitted handleless base and wall units with a worktop, space and plumbing for a washing machine, space for a tumble-dryer, decorative tiled splashback, tiled flooring, an extractor fan, a singular recessed spotlight, and a single composite door providing access to the garden.

The second en-suite has a low level dual flush WC, a pedestal wash basin, a shower enclosure with a mainsfed shower, partially tiled walls, Amtico flooring, a heated towel rail, recessed spotlights, an extractor fan, and a UPVC double-glazed obscure window to the rear elevation.

The third bedroom has a UPVC double-glazed window to the rear elevation, carpeted flooring, and a radiator.






