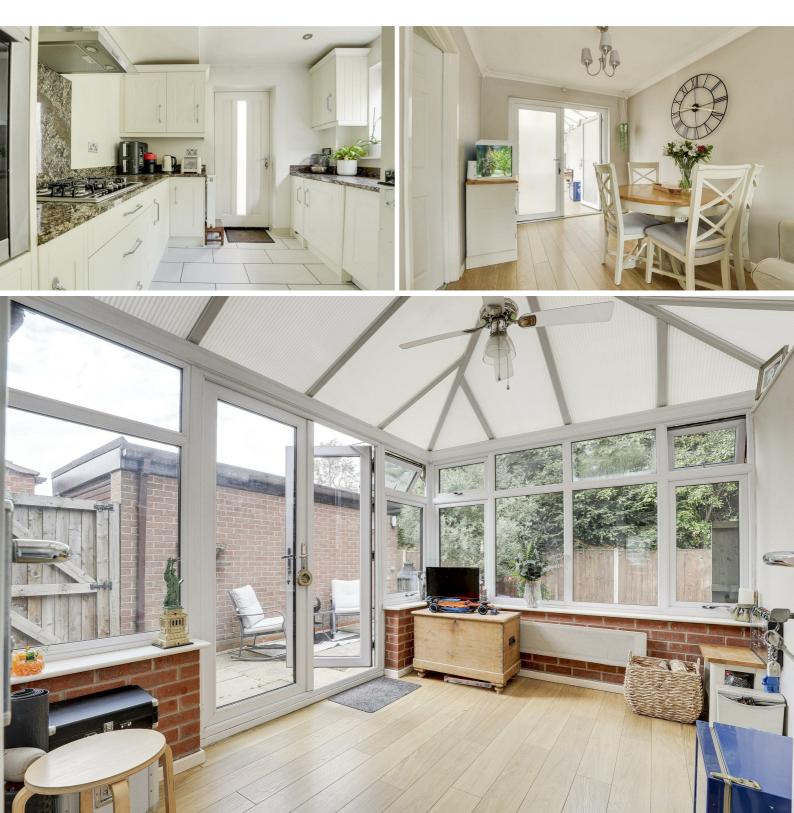

Entrance Hall

The entrance hall has carpeted flooring, a radiator, a wall-mounted thermostat, an un-built cupboard, and a UPVC door providing access into the accommodation..

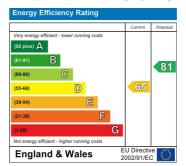

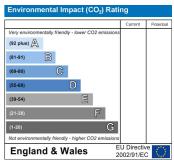

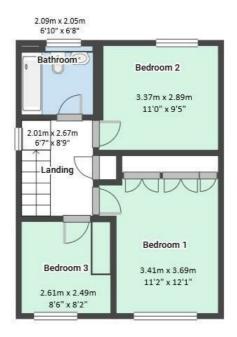
