Upvc double glazed french doors to rear, radiator, power points, laminate flooring.

Kitchen/Breakfast Room 16'6" x 9'2" (5.04 x 2.80)

Two Upvc frosted double glazed windows to side, one Upvc double glazed window to rear, eye & base level units with roll edge work tops, sink/drain, built in fridge/freezer, dishwasher & microwave, tiled flooring, radiator, power points.

Utility Room 18'11" x 8'1" (5.77 x 2.48)

Upvc double glazed windows to side & rear, base level units with roll edge work tops, sink/drain, plumbing & space for washing machine & dishwasher.

Rear Lobby 6'2" x 5'10" (1.89 x 1.80)

Upvc double glazed door & window to rear, tiled flooring. Door to:

Upvc double glazed windows to front, radiator, power points.

Bedroom 4 12'0" x 11'8" (3.66 x 3.58)

Upvc double glazed windows to rear, radiator, power points.

Shower Room 5'10" x 4'9" (1.79 x 1.45)

Upvc frosted double glazed window to side, shower cubicle, pedestal wash hand basin, heated towel rail, partly tiled walls, airing cupboard.

Bathroom 9'2" x 8'10" (2.80 x 2.70)

Upvc frosted double glazed windows to both side & rear, freestanding bath, low level wc & pedestal wash hand basin, radiator.

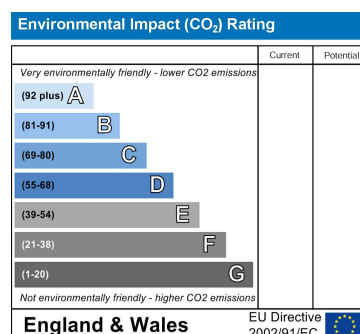
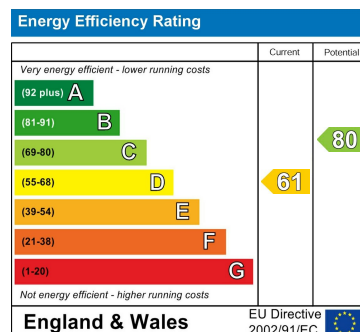
