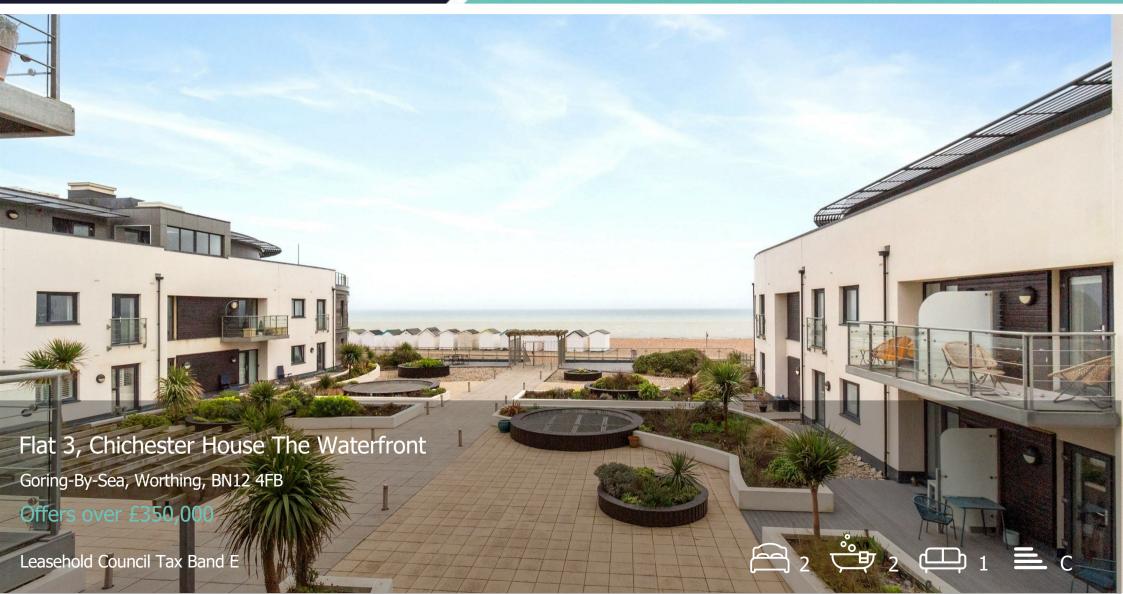

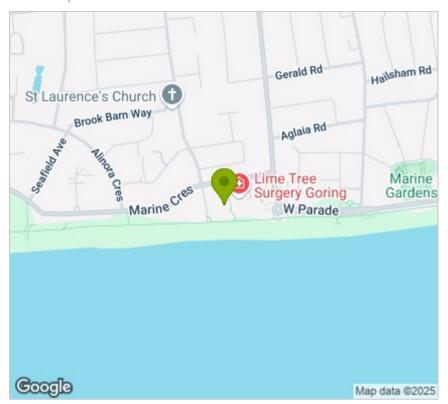
Floor Plan



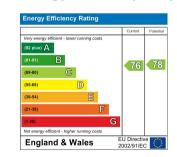

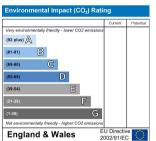
