Ground Floor

Upon entry to the accommodation you step into the entrance hall with a staircase rising to the first floor and a door leading through to the reception room presented with wood effect flooring. Positioned around a feature fireplace, there is light provided by a window overlooking the front elevation, useful open cupboard under the stairs and a door leading through to the full width kitchen diner fitted with a range of wall mounted and base units with complementary roll edge work surfaces over, tiled splashbacks, inset 1.5 sink and drainer and cooker (included). Doors open into the extension conservatory providing additional downstairs living space with dual aspect glazing.

First Floor

Moving upstairs you will find three bedrooms, the light and airy main bedroom being larger than average in size and extending the full width of the property. Completing the first floor is the bathroom fitted with a three piece suite comprising a bath with shower over, wash hand basin and WC.

Outside

The plot boasts parking to the front providing off road parking with shared gated access to the side leading to a particularly private garden featuring various areas for outdoor entertaining and a brick store providing useful storage.


