Extended to the side, fall in love with this contemporary styled and enlarged three bedroom semi detached home situated within arguably one of Melton's most desirable villages. Benefiting from gas central heating and double glazing, the layout includes an entrance hallway, lounge with half bay and media wall, with open access through to the kitchen diner, conservatory, utility room and WC. Upstairs vou will find three bedrooms (the master benefiting from having an en-suite shower room) and a contemporary styled bathroom. The plot offers parking to the front, with a landscaped rear garden. Occupying a family friendly cul de sac position, an early viewing is highly recommended.

Ground Floor

Upon entering the home, you're welcomed into an entrance hall featuring a staircase to the first floor, built-in storage, and access to the kitchen.

The kitchen is fitted with modern units, Zenith resin worktops, an integrated fridge, freezer, dishwasher, a double gas hob with extractor hood, and an inset sink and a half. Wood-effect flooring flows through to the spacious reception room, which boasts a feature media wall with an inset electric fireplace. The conservatory adds valuable additional living space, with doors opening out to the rear garden. A separate utility room offers further storage and appliance space, along with access to a convenient guest WC.

First Floor

Moving upstairs you will find three bedrooms, the refurbished master bedroom benefiting from having built in wardrobes and a feature panelled wall as well as access to it's own en-suite fitted with a shower cubicle, wash hand basin and WC. The family bathroom completes the first floor and is fitted with a thee piece suite comprising a bath with shower fitment, WC, wash hand basin, heated towel rail, laminate flooring, velux window and built in storage.

Outside

Occupying a tucked-away cul-de-sac position, the property benefits from a driveway providing off-road parking. Gated side access leads to a low-maintenance rear garden, featuring a decking area ideal for outdoor seating and entertaining, a synthetic lawn, and fenced boundaries for privacy.
