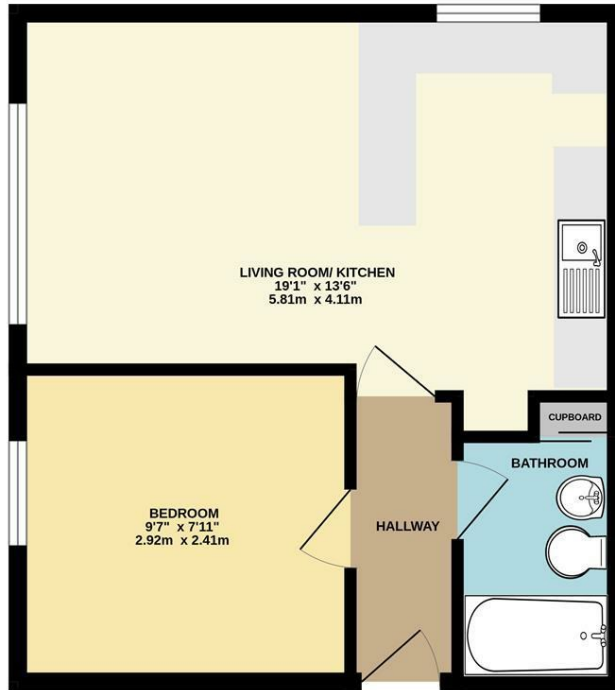

GROUND FLOOR

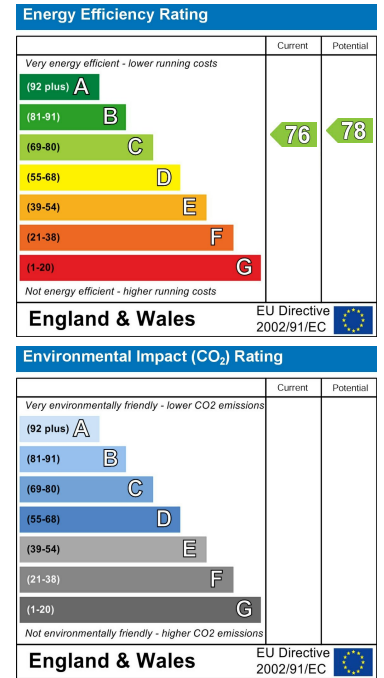
