This opportunity holds enormous potential (subject to planning) for renovation/conversion and/or site development. Down Farm Barn (also known as Crimea Barn) occupies a prominent, semi-rural, corner position at the junction of Chalton Lane with Green Lane, some 3/4 mile only from Clanfield Village Centre.







Believed to date from around 1850, the barn is an 'L'-shaped Victorian building, circa 2000 sq ft, of mainly Sussex-flint construction under a corrugated roof. It stands upon a generous plot, approached via Downview Way, and having road frontage to the north and west.

MEASUREMENTS

The barn has three adjoining sections, as follows:

Section 1

30'0 x 18'8 (9.14m x 5.69m)

Section 2 ('L'-shaped)

28'9 x 16'10 (8.76m x 5.13m) Plus 17'10 (5.44m) x 16'10 (5.13m)

Section 3

40'0 x 16'10 (12.19m x 5.13m)

Total Floor Area: 1988 sq ft approx.

The Lot is offered now "as is", namely with no consent in place for alternative use, either of the existing building or its surrounding land. Conditional offers will NOT be considered by the Sellers. 
