DESCRIPTION

A mid-terraced two-bedroom period house on a quiet residential street in St George. The property has been rented out in recent years and would now benefit from some updating. The property boasts a spacious living room with bay window, a second reception room, two double bedrooms, a kitchen with a utility room and WC and a West-facing private rear garden. There is scope to add value by converting the loft or extending to the rear. The property will appeal to both private buyers and investors alike, with a estimated rental income of circa £1,600 per calendar month (£19,200 per annum).

LOCATION

The property is situated on Kensington Road in St George, just off Bell Hill Road. A wide range of amenities are available locally and excellent transport links are provided to the city centre. 
