DESCRIPTION

An exciting opportunity to purchase a level building plot with full planning consent granted for the erection of a detached bungalow with parking and gardens. The site measures approximately 244 m² and benefits from direct access onto Crome Road. A superb opportunity for builders and developers in an area undergoing significant redevelopment.

LOCATION

The land is situated to the rear of 98, 98A and 100 Landseer Avenue with access off Crome Road in Lockleaze. Easy access is provided to a range of local amenities on Gainsborough Square and the popular Trinity Academy is just 0.7 km away.

PROPOSED DWELLING - 54 m²

The proposed bungalow will comprise of an entrance porch, an open-plan kitchen/living room, double bedroom, bathroom and an additional study/second bedroom. Externally, the property will benefit from off-street parking to the front and gardens to the front, side and rear.

GROSS DEVELOPMENT VALUE (GDV)

We would anticipate a GDV in the region of £250,000.


