There is a sumptuous 26x16 ft open-plan kitchen reception room flooded with natural light which opens out through bifold doors onto the 34-ft private garden. There are two comfortable double bedrooms - including the 12x11 ft bay-fronted principal bedroom with build-in floor-to-ceiling storage - as well as a modern family bathroom.

Dunstans Road is enviably-located on the old Friern Manor Estate for the wonderful parks and green spaces as well as the independent shops, bars, restaurants and coffee shops of Lordship Lane, North Cross Road and Forest Hill Road. There are strong transport links into The City and East London from Peckham Rye station (1.5 miles) and Honor Oak Park station (1.1 miles) as well as bus/cycle routes through the neighbouring Dulwich Village, Forest Hill and Nunhead.






Floorplan
