Guide price £450,000 - £475,000 - Charming, spacious and beautifully-bright two double bedroom apartment at the top of this unique art-deco building with stunning city views in the heart of residential East Dulwich, SE22.

Boasting over 675 Sq Ft of internal space – this fourth-floor apartment enjoys stunning rooftop and cityscape views from the 14x11 ft reception room and the 15x9 ft principal bedroom with built-in wardrobes. There is a further double bedroom, family bathroom and a separate kitchen. With cork flooring throughout, the property has been well-maintained by the current owners - but would benefit from some gentle modernisation in places.

The desirable Mundania Court offers excellent access into The City and West End from Honor Oak Park station (0.7 miles) and Peckham Rye station (1.4 miles) as well as bus and cycle routes through the neighbouring Forest Hill, Nunhead and Dulwich Village.

There are a host of excellent parks and green spaces nearby as well as the independent shops, pubs and restaurants of Forest Hill Road, Lordship Lane and Honor Oak Park.

Built in circa 1933 - the art-deco-inspired apartments are built around a self-enclosed rear courtyard which - along with the other communal areas are well-maintained by the active resident committee. The property enjoys a healthy underlying lease and a share in the freehold company.

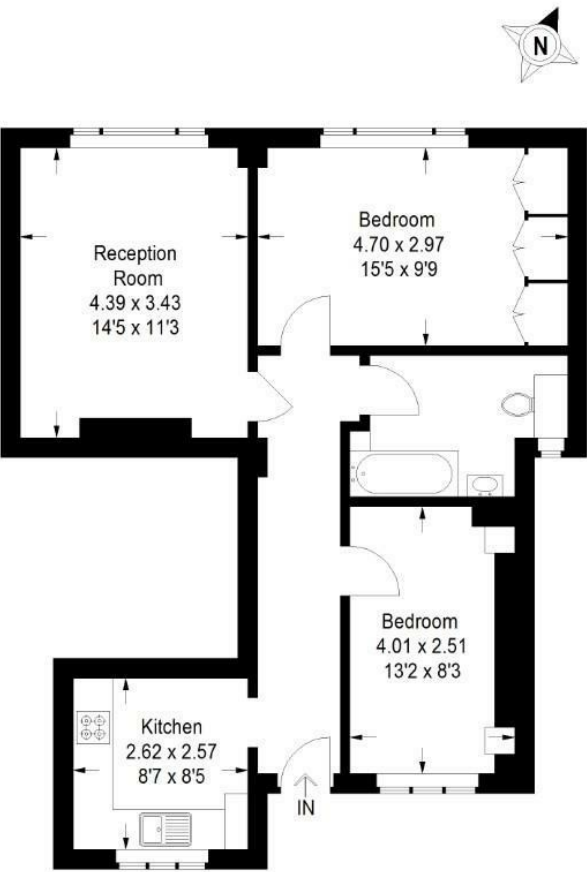

Floorplan

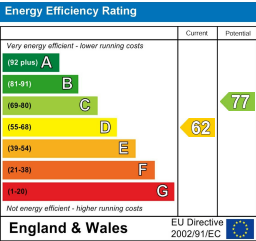
Mundania Court, Forest Hill Road, SE22
