# 1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The subjects comprise a converted, self-contained ground floor main door apartment, part of a detached two storey and lower floor villa converted to form three units around 1979. The property is on ground floor and there is a lower ground floor flat below.

Neighbourhood and location	The property is located approximately 3 miles east of Dundee city centre within an established good class residential district of Broughty Ferry. Surrounding properties are of a mixed residential nature and adequate secondary shopping, public transport, social and educational facilities can be found within easy reach. The property enjoys panoramic views towards the Tay Estuary.

Weather	Sunny and dry.
Chimney stacks	The chimney stacks are of solid stone construction served with metal and cement flashing where viewed.
	A very restricted inspection was possible from ground level.
	Visually inspected with the aid of binoculars where appropriate.
Roofing including roof space	The roof is of pitched timber construction, externally clad in slate with zinc ridging, hips and valleys. There is a flat mineral felt covering over the east most historic extension. No view was possible of the flat roof or the central valley section. Access to the roof space is presumably via hatches within the private upper floor flat.  Sloping roofs were visually inspected with the aid of binoculars where appropriate.  Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.
Rainwater fittings	Rainwater goods are of solid stone parapet gutters and cast iron and PVC traditional style fittings. No view was possible of the parapet gutters.  Visually inspected with the aid of binoculars where appropriate.

# The main walls are of solid stone construction. The east most extension has an external rendered finish. The Sun Room is timber and glazed on a brick and rendered base. A very restricted inspection was possible of this space due vegetation growth. Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

# Windows, external doors and joinery The windows within the main building are mainly uPVC, double glazing although there is a double glazed timber casement window within the Bathroom and an original timber sash window within the rear corridor which is served with double glazed inserts. Single glazing is provided within the Sun Room and also within the Vestibule. Access to the property is by means of the original timber panel entry door and there is a timber and glazed door from the Sun Room to the garden. There is a uPVC, double glazed door from the Study to the side garden area. Internal and external doors were opened and closed where keys were available.

Random windows were opened and closed where possible.

Doors and windows were not forced open.

External decorations	Visually inspected.
Conservatories / porches	The Sun Room is constructed on a brick base, partially rendered and a very restricted inspection of this was possible due to vegetation growth. The windows are of single glazed, timber casement design, while the roof is mono pitched and part slate and part glazed.  Visually inspected.

# Garages and permanent outbuildings

There is a quadruple car garage at the foot of the site and this belongs to the subject property and also the lower ground floor property. This is of brick construction, externally rendered with a profile steel roof over. There is no internal division between the garages and the subjects benefit from a workshop area to the rear of this building, accessed from the north side. The liability and ownership rights of this garage should be clarified.

Visually inspected.

#### **Outside areas and boundaries**

The subjects has its own exclusive area of garden ground to the west side of the property and also a pathway to the rear which leads to a drying area to the east side of the property. These garden areas are enclosed with substantial stone walls and also drystone walls within the garden grounds. Also incorporated within the grounds, is a steel and masonry platform giving access to the upper flat while there are cast iron grilles and steps incorporated within areas of the garden ground.

Visually inspected.

#### Ceilings

The ceilings are of timber lath and plaster throughout with ornate cornice work provided within the main apartments. Lowered plasterboard ceilings are provided at points. The ceilings have a papered and painted finish.

Visually inspected from floor level.

#### Internal walls

Internal walls appear to be of stone construction plastered on the hard, brick construction plastered on the hard, timber lath and plaster and timber stud overlaid in plasterboard. Internal surfaces are painted and papered and the walls are fully tiled within the Bathroom and partially tiled within the Kitchen.

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

# Floors including sub floors The flooring within is of suspended timber and suspended concrete construction. Due to fitted carpets and floor coverings, no inspection was possible of the floor timbers and accordingly we cannot guarantee their soundness or otherwise. Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted. Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point. Internal joinery and kitchen The internal doors are mainly of the original timber panel and timber fittings and glazed design. The Kitchen units are modern. accommodation within is fair. There are timber steps within the rear corridor giving access to the Study and Cloakroom. Built-in cupboards were looked into but no stored items were moved. Kitchen units were visually inspected excluding appliances. Chimney breasts and fireplaces There is a timber and tiled fireplace within the Lounge, served with a wood burner and a marble and tiled fireplace within the main Bedroom which lies open. Any other fireplaces have been removed/blocked and presumed adequately vented. Visually inspected. No testing of the flues or fittings was carried out. Internal decorations Visually inspected.

#### **Electricity**

Mains supply.

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

#### Gas

Mains supply.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

# Water, plumbing, bathroom fittings

Mains supply of water. There is a stainless steel sink unit in the Kitchen and the plumbing below this is in PVC and copper design. Fittings within the Bathroom and Cloakroom areas are on modern lines.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances.

Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

#### Heating and hot water

Space heating is by means of a gas fired system and the radiators are served with partial individual thermostats. There is a `Worcester Greenstar` condensing combination boiler within the rear corridor cupboard and this is served with a fan assisted flue. The central heating system provides domestic hot water.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

#### **Drainage**

Presumably connected to the main public sewer.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

#### Fire, smoke and burglar alarms

Smoke alarms are provided within the property.

No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

#### **Additional limits to inspection**

It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

No close inspection was possible of the roof covering due to the contours of the site.

Only the subject flat and communal areas giving access to the flat were inspected.


If the roof space or under-building / basement is communal, reasonable and safe access is not always possible. If no inspection was possible, this will be stated. If no inspection was possible, the surveyor will assume that there are no defects that will have a material effect on the valuation.

The building containing the flat, including any external communal areas, was visually inspected only to the extent that the surveyor is able to give an opinion on the general condition and standard of maintenance.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

## 4. Valuation and conveyance issues

## Matters for a solicitor or licensed conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

A check should be made to ascertain if the property is listed. Alterations have been carried out within the property, although we are unaware of any recent alterations.

The exact ownership of the garden grounds should be clarified with reference to the title plan.

The liability for external maintenance and repairs should be ascertained.

# Estimated reinstatement cost for insurance purposes

#### £950,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £950,000 (Nine Hundred and FiftyThousand Pounds Sterling).

#### Valuation and market comments

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £390,000 (THREE HUNDRED AND NINETY THOUSAND POUNDS STERLING).

#### TERMS AND CONDITIONS OF SINGLE SURVEY

**GENERAL** 

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. Yes

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

#### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

The Report and any expressions or assessments in it are not intended as advice to the Seller or Purchaser or any other person in relation to an asking price or any other sales or marketing decisions.

The Report is based solely on the Property and is not to be relied upon in any manner whatsoever when considering the valuation or condition of any other property.

If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

#### 1.3 Liability

The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

The Report is addressed to the Seller and is prepared in the expectation that it (or a complete copy) along with these Terms and Conditions (or a complete copy) would be (or, as the case might be, would have been) disclosed and delivered to:

- the Seller:
- any person(s) noting an interest in purchasing the Property from the Seller;
- any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- the Purchaser: and
- the professional advisors of any of these.

The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.





## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. ## The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 50 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. ## About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

#### 1 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide long-lasting weather protection. It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

#### 2 Low energy lighting

Replacement of traditional light bulbs with energy saving bulbs will reduce lighting costs over the lifetime of the bulb, and they last many times longer than ordinary light bulbs. Low energy lamps and fittings are now commonplace and readily available. ## Low and zero carbon energy sources
