

# 1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

	Half landing - bathroom.

Neighbourhood and location	The subjects form part of a long established private residential location
	within Broughty Ferry, close to Dawson Park. Surrounding properties
	are of a relatively similar nature and all amenities can be found within
	easy reach.

Chimney stacks	The chimney stacks are of brick construction, served with metal flashings.
	Visually inspected with the aid of binoculars where appropriate.

Roofing including roof space	The roof is of pitched timber construction, externally laid in slates and incorporating metal ridging. Access to the roof space is via a hatch in the upper floor landing and there is a timber folding drop down ladder.
	The roof space was found to be part floored and is insulated at joist level. No access was gained to the rear outshoot void and no access was gained to any eaves spaces.
	Sloping roofs were visually inspected with the aid of binoculars where appropriate.
	Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems
	it safe and reasonable to do so.

Rainwater fittings	The rainwater goods are of PVC and cast-iron design. There is a central
	valley gutter between the property and its neighbour which could not
	be viewed.
	Visually inspected with the aid of binoculars where appropriate.

Main walls	The main walls are of solid stone construction, internally lined.
	The main walls to the rear outshoot appear to be of solid brick construction, externally painted.
	Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

Windows, external doors and joinery	The windows are of mixed age and design, with a number of original timber units retained. Units at the rear have been upgraded in the past to a upvc type.
	There is a timber entry door and timber double doors within the lounge giving access to the garden. There is also a rear upvc door.
	Internal and external doors were opened and closed where keys were available.
	Random windows were opened and closed where possible.
	Doors and windows were not forced open.

External decorations	Elements of the external fabric have a painted finish.
	Visually inspected.

	Our inspection was restricted due to contents.
	Visually inspected.

Outside areas and boundaries	There are areas of private ground pertaining to the property, with an elongated rear garden, and these are bounded by traditional stone walls and timber fencing. Our inspection was restricted due to vegetation.
	Off-street parking is provided on a private drive. Visually inspected.

Ceilings	The ceilings appear to be of lath and plaster and plasterboard design.
	Visually inspected from floor level.

Internal walls	The internal walls appear to be of masonry construction, plastered on the hard and timber lath and plaster.
	Visually inspected from floor level.
	Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

	Access to the sub-floor area is via a hatch within the utility cupboard.
	Only a restricted view was possible from around the hatch due

	floor coverings were lifted.
	Sub-floor areas were inspected only to the extent visible from a
	readily accessible and unfixed hatch by way of an inverted "head and
	shoulders" inspection at the access point.
	Physical access to the sub floor area may be taken if the Surveyor
	deems it is safe and reasonable to do so , and subject to a minimum
	clearance of 1m between the underside of floor joists and the solum
	as determined from the access hatch.

	Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

	Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that

Water, plumbing, bathroom fittings	Mains supply. There is a sink unit in the kitchen and the plumbing where viewed is of PVC and copper design.
	The shower-room incorporates a wc, wash-hand basin, bath and electric shower in cubicle.
	Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.
	It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Heating and hot water	Space heating is by means of a gas fired system. There is a Worcester Greenstar condensing regular boiler located within the utility room and this feeds wall-mounted radiators. The associated hot water cylinder is located within the landing cupboard. The heating system appears to provide domestic hot water.
	Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Drainage	Mains sewer connection assumed.
	Drainage covers etc were not lifted.
	Neither drains nor drainage systems were tested.

Fire, smoke and burglar alarms	Visually inspected. No tests whatsoever were carried out to the system
	or appliances. New smoke alarm standards were introduced in
	Scotland in February 2022 and it is likely that some properties may
	require additional works to meet these standards. In instances where
	alarms are in place, no tests whatsoever have been carried out and we
	cannot confirm if the system complies with the most recent
	regulations. Any potential purchaser should satisfy themselves as to
	whether the current system meets with regulations or otherwise.

Additional limits to inspection	It is outwith the scope of this inspection to determine whether or not
	asbestos based products are present within the property. Asbestos
	was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should
	engage the services of a qualified asbestos surveyor.
	It should be appreciated that the Home Report inspection is a non- disruptive visual inspection of the property as at the date of
	inspection and that we are unable to inspect parts of the property
	which are concealed or covered by floor coverings or contents in
	place at that time. Once vacant, defects may be apparent that could
	not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at
	the time of inspection.
	No inspection for Japanese Knotweed was carried out and unless
	otherwise stated for the purpose of this report, it is assumed that
	there is no Japanese Knotweed within the boundaries of the property
	or in neighbouring properties.
	The property was fully furnished at the time of our inspection and the
	services were not tested.

## Valuation and market comments

### £400,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £400,000 (Four Hundred Thousand Pounds Sterling).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

# TERMS AND CONDITIONS OF SINGLE SURVEY

#### GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If the Surveyor suspects that a defect may exist within an unexposed area and which could have a material effect upon the value, he may recommend further investigation by specialist contractors.

#### 2.4 Services



### The energy efficiency rating of your home

### About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

#### 1 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide longlasting weather protection. Further information can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

#### 2 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

#### 3 Low energy lighting

Replacement of traditional light bulbs with energy saving bulbs will reduce lighting costs over the lifetime of the bulb, and they last many times longer than ordinary light bulbs. Low energy lamps and fittings are now commonplace and readily available. Information on energy efficiency lighting can be found from a wide range of organisations, including the Energy Saving Trust (http://www.energysavingtrust.org.uk/home-energy-efficiency/lighting).

#### 4 Heating controls (room thermostat)

The heating system should have a room thermostat to enable the boiler to switch off when no heat is required. A competent heating engineer should be asked to do this work. Insist that the thermostat switches off the boiler as well as the pump and that the thermostatic radiator valve is removed from any radiator in the same room as the thermostat. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

#### 5 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent).
