### 1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The subjects comprise a detached one and a half storey extended dwellinghouse.

Neighbourhood and location	The subjects are situated within a predominantly residential location approximately three miles north west of Dundee City Centre. Surrounding properties are of similar class and nature with excellent amenities available within easy reach.

Chimney stacks	Visually inspected with the aid of binoculars where appropriate.
	The chimneys serving the property would appear to be of brick construction externally harled with the flashings, where seen from ground level, appearing to be of lead design.

### Roofing including roof space

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.

Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

The roof over the main property is of pitched timber construction overlaid in interlocking concrete tiles with dormer projections on both the front and rear pitches. The roofs over the dormers are of flat design (unseen).

The roof over the rear outshoot is of mono pitched design laid in interlocking concrete tiles.

No access was gained to any apex areas with access only to a small area of eaves to the front of the subjects. This area was found to be partially floored, insulated with contents within.

### Rainwater fittings

Visually inspected with the aid of binoculars where appropriate.

The rainwater goods serving the property are of PVC design.

### Main walls Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected. The main walls of the property would appear to be of cavity brick construction externally harled with facing brick and timber weatherboarding features. The rear outshoot would also appear to be of cavity brick construction externally harled. Windows, external doors and Internal and external doors were opened and closed where keys were available. joinery Random windows were opened and closed where possible. Doors and windows were not forced open. The windows are of uPVC casement double glazed design with the exception of Velux rooflights within the rear outshoot and one on the front pitch at first floor level. Access to the property is via a uPVC and glazed front entrance door with a timber and glazed door to the side and uPVC double glazed French doors within the sitting room. **External decorations** Visually inspected. PVC finish to windows and doors, external timbers painted. Conservatories / porches None Communal areas None Garages and permanent Visually inspected.

# outbuildings There is a single car garage of concrete block construction externally harled with an adjoining store of brick and timber design. The roof over the garage is of flat felt design with a Perspex roof over the store. Access to the garage is via an up and over door (not checked or tested) as well as a timber personnel door to the side. The garage benefits from light and power (not checked or tested).

### **Outside areas and boundaries**

Visually inspected.

There are garden grounds to the front, side and rear. These are predominantly laid in grass with paved and mono block sections also. Boundaries are predominantly of concrete block design including retaining walls although there are also timber fencing to the rear.

### Ceilings

Visually inspected from floor level.

Ceilings would appear to be of timber stud design overlaid in plasterboard, plastered and painted with recessed lighting within a number of the apartments.

### Internal walls

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

Internal partitions would appear to be of brick plastered on the hard as well as timber stud overlaid in plasterboard.

There is a splash back to the walls within the dining kitchen with timber cladding to the walls within the ground floor hallway and on the stair. Wet walling has been added to the shower room walls with full tiling within the en suite.

### Floors including sub floors

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so, and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.

Flooring within the property is of suspended timber construction with fitted floor coverings throughout. No sub-floor inspection was made as no access hatch could be found.

	Wardrobes have been fitted within the bedrooms and cupboard accommodation is typical for a property of this type and age.

Electricity	Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.
	Mains supply of electricity with 13 amp power outlets within the main apartments. The electricity consumer unit and meter are located within the hallway.

### Gas

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Mains supply of gas with the gas meter box located externally.

### Water, plumbing, bathroom fittings

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Mains supply of water and plumbing, where seen, is of PVC and copper design. Modern sink units have been installed within the dining kitchen and utility room. Shower room, bathroom and en suite shower room fitments are on modern lines.

### Heating and hot water

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

There is a full gas fired central heating system within the property with radiators located within the main apartments. The central heating piping would appear to be of mixed copper design with the radiators benefitting from individual thermostatic controls. As well as the radiators, there are a number of heated towel rails.

Domestic hot water would appear to be provided via the central heating system with the boiler being of a Worcester Greenstar design located within the utility room. It is understood that the system is serviced on an annual basis. Copies of the most recent documentation should be obtained.

# Drainage Drainage covers etc were not lifted. Neither drains nor drainage systems were tested. Drainage is assumed to be connected to the main public sewer.

# Fire, smoke and burglar alarms Visually inspected. No tests whatsoever were carried out to the system or appliances. New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise. There are smoke alarms fitted within the property.

### **Additional limits to inspection**

It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.


Only a very limited inspection was possible of the front eaves with no inspection possible of any apex areas.

The property was fully furnished at the time of our inspection and the services were not tested.

Due to fitted carpets and floor coverings no detailed inspection was possible of the floor timbers and accordingly we cannot guarantee their soundness or otherwise.

The inspection of the garage, both internally and externally, was limited - internally due to contents and externally due to neighbouring properties.

Notes	These appeared generally in fair condition consistent with age. It should be appreciated that flashing details require ongoing maintenance to ensure watertightness.

Notes	The roof coverings are original. From ground level only a limited inspection was possible however, where seen, there are lifting, cracked and weathered tiles. No inspection was made of the flat roofs over the dormer projections. The flat roofs would appear to be of modern design however no comment can be made as to their condition. It should be appreciated that any flat roof has a limited life and will require regular maintenance and eventual renewal. The condition of the flat roofs should be confirmed prior to purchase.
	The roof covering is now of an age where ongoing and regular maintenance will be required and it would be prudent to seek the advice of a roofing contractor prior to purchase to comment on its current condition and expected lifespan.
	As stated previously, only a small area of the front eaves was possible to be inspected. Contents, insulation and flooring greatly restricted this inspection.

### Rainwater fittings

Notes	At the time of our inspection there was no evidence of damp staining/water staining on wall surfaces which would indicate leakage. It should be noted that it was not raining at the time of our inspection.



### Main walls

Notes	There are areas of some cracked and patched harling. Ongoing maintenance and repairs should be anticipated. Some discolouration was noted to the harling also, the cause should be confirmed and any necessary repairs implemented.



### Windows, external doors and joinery

Notes	The windows have been replaced in the past. When these works were carried out is however unknown. Whilst not all windows were checked or tested, the windows that were would appear to be in a condition consistent with their type and age.
	Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/repair will be required as part of an ongoing maintenance programme.
	Double glazed windows may be prone to misting/interstitial condensation which can be more evident and can change in certain temperatures/weather conditions.
	The timber and glazed door within the utility room is semi-modern and weathered in places.



### **External decorations**

Notes	The external decorations are generally in fair order. Regular repainting will be required if these areas are to be maintained in satisfactory condition.  There is a section of uPVC eaves boarding to the rear which appears to be slightly warped. Inspect to ascertain condition and carry out repairs as required. To the front of the property there is a hole within the eaves boarding which will require to be made good.

### **Garages and permanent outbuildings**

Notes	The inspection of the garage was extremely limited due to contents. The roof over is of flat felt design and it should be appreciated that any flat roof has a limited life and will require regular maintenance and eventual renewal. During the inspection evidence of water ponding was noted to the garage roof.
	The up and over door was not checked or tested. This would appear to be on older lines and should be inspected to confirm that it is in working order. The personnel door has been affected by decay and will require maintenance.
	The electrics to the garage were not checked or tested.
	Externally there are areas of missing harling and there is evidence of movement between the garage and rear store. Inspect and repair as necessary.



### **Outside areas and boundaries**

Notes	Garden grounds would generally appear to have been well maintained. We understand that a section of the north retaining wall has recently been renewed. There are smaller boundary and retaining walls to the front and within the garden grounds that have been affected by movement. Ongoing maintenance and repair should be anticipated. Slight fire damage was noted to the timber fencing to the rear.

Notes	Fitted floor coverings greatly restricted the inspection of the flooring. No sub-floor inspection was made and accordingly no comment can be made as to the condition of timbers within this area.  Areas of spillage to flooring within the shower room at first floor level. Inspect and repair as/if necessary.
	Access was gained to a small area of the sub-floor area via an external door. This area has been laid in concrete and it was noted that insulation has been laid below the flooring. The solum would appear to have been sealed. Only a head and shoulders inspection was made via a hole within the sleeper wall.

### 4. Valuation and conveyance issues

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

The valuation is made on the assumption that all alterations carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include

### Estimated reinstatement cost for insurance purposes

### £675,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £675,000 (Six Hundred and Sventy Five Thousand Pounds Sterling).

### Valuation and market comments

### £360,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £360,000 (Three Hundred and Sixty Thousand Pounds Sterling).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

### TERMS AND CONDITIONS OF SINGLE SURVEY

**GENERAL** 

### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. Yes

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

The Report and any expressions or assessments in it are not intended as advice to the Seller or Purchaser or any other person in relation to an asking price or any other sales or marketing decisions.

The Report is based solely on the Property and is not to be relied upon in any manner whatsoever when considering the valuation or condition of any other property.

If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.






### **Energy Efficiency Rating**

### The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO<sub>2</sub> emissions, running costs and the savings possible from making improvements.

### The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 34 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 7.2 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 2.3 tonnes per year. ### About the recommended measures to improve your home's performance rating

### 1 Cavity wall insulation

Cavity wall insulation, to fill the gap between the inner and outer layers of external walls with an insulating material, reduces heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. The insulation material is pumped into the gap through small holes that are drilled into the outer walls, and the holes are made good afterwards. As specialist machinery is used to fill the cavity, a professional installation company should carry out this work, and they should carry out a thorough survey before commencing work to ensure that this type of insulation is suitable for this home and its exposure. They should also provide a guarantee for the work and handle any building standards issues. Further information about cavity wall insulation and details of local installers can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk).

### 2 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

### 3 Replacement glazing units

Replacing existing double-glazed units with new high-performance units. Building regulations require that replacement glazing is to a standard no worse than previous; a building warrant is not required. Planning permission might be required for such work if a building is listed or within a conservation area so it is best to check with your local authority.

### 4 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

### Low and zero carbon energy sources

Low and zero carbon (LZC) energy sources are sources of energy that release either very little or no carbon dioxide into the atmosphere when they are used. Installing these sources may help reduce energy bills as well as cutting carbon.
