# 1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

<b>Neighbourhood and Location</b>	The subjects are situated close to Broughty Ferry centre where surrounding properties are predominantly of a private residential nature. Excellent amenities are available within easy reach.

<b>Chimney Stacks</b>	<p>Visually inspected with the aid of binoculars where appropriate.</p> <p>The chimneys, where seen from ground level, are of solid stone constructions with the flashings, again where seen from ground level, being of lead design.</p>

<b>Roofing including Roof Space</b>	<p>Sloping roofs were visually inspected with the aid of binoculars where appropriate.</p> <p>Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.</p> <p>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.</p> <p>The roof is of pitched timber design overlaid in slate with tiled riding. The roof metalwork is of lead design. There is a mono pitched roof over the kitchen, this is laid in mineral felt.</p> <p>From ground level, due to the design of the roof structure, some sections of the roof coverings were unable to be inspected.</p> <p>Access was gained to the roof void via a hatch within the first floor hall cupboard. The inspection of the roof void was restricted due to the design of the roof structure itself and the lack of proper crawl boards. Where seen, the attic has been partially insulated.</p> <p>There is no roof void over the rear outshoot with the ceiling being sloping .</p>

<b>Rainwater Fittings</b>	<p>Visually inspected with the aid of binoculars where appropriate.</p> <p>Rainwater goods are of traditional cast iron and modern PVC design as well as various valley gutters incorporated into the roof structure. No inspection was made of the central valley gutter.</p>

<b>Main Walls</b>	<p>Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.</p> <p>The main walls of the property are of solid stone construction with the rear extension appearing to be of single brick design externally rendered.</p>

<b>Windows, External Doors and Joinery</b>	<p>Internal and external doors were opened and closed where keys were available.</p> <p>Random windows were opened and closed where possible.</p> <p>Doors and windows were not forced open.</p> <p>The windows are of mixed design and age, being predominantly of aluminium/uPVC casement double glazed design.</p> <p>Access to the property is via a timber and glazed door with a modern uPVC glazed door to the rear.</p>

<b>External Decorations</b>	<p>Visually inspected.</p> <p>PVC finish to windows, external timbers painted.</p>

<b>Garages and Permanent Outbuildings</b>	<p>Visually inspected.</p> <p>There is a single car garage pertaining to the property, this is of concrete block/brick construction with the roof over appearing to be of concrete deck design. Access to the garage is via a roller door (not checked or tested) as well as a timber personnel door to the side. The garage benefits from light and power.</p> <p>Outbuildings comprise an integrated store to the rear of the kitchen as well as a timber shed.</p>

<b>Outside Areas and Boundaries</b>	<p>Visually inspected.</p> <p>There are garden grounds to the front, side and rear. The front garden provides off-street parking for the subjects with the rear garden paved. Boundaries are of concrete block and stone design.</p>

<b>Ceilings</b>	<p>Visually inspected from floor level.</p> <p>The ceilings would appear to be of the original lath and plaster and timber stud overlaid in plasterboard with ornate and plain cornice features within a number of the apartments.</p>

<b>Internal Walls</b>	<p>Visually inspected from floor level.</p> <p>Using a moisture meter, walls were randomly tested for dampness where considered appropriate.</p> <p>Internal partitions would appear to be of brick plastered on the hard and timber stud as well as timber lath and plaster. The walls within the various shower rooms/bathrooms have various linings including tiling and wet walling.</p>

<b>Floors Including Sub-Floors</b>	<p>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.</p> <p>Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.</p> <p>Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.</p> <p>Flooring within the property is of suspended timber and solid concrete design with fitted floor coverings throughout.</p> <p>No access was gained to the sub-floor area as no access hatch could be found.</p>

<b>Internal Joinery and Kitchen Fittings</b>	<p>Built-in cupboards were looked into but no stored items were moved.</p> <p>Kitchen units were visually inspected excluding appliances.</p> <p>The internal doors are of timber panel, timber flush panel and timber and glazed design.</p> <p>There is a fitted kitchen within the property with both base and wall units.</p> <p>Access to the first floor level is via the original timber stair.</p>

<b>Chimney Breasts and Fireplaces</b>	<p>Visually inspected. No testing of the flues or fittings was carried out.</p> <p>The majority of the fireplaces have been removed previously. There is however a brick feature surround within the lounge which would still appear to be in use (not checked or tested).</p>

<b>Electricity</b>	<p>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains supply of electricity with 13 amp power outlets within the main apartments. The electricity consumer unit and meter are located within the lounge wall press.</p>

<b>Gas</b>	<p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>Mains supply of gas with the gas meter box located externally.</p>

<b>Water, Plumbing and Bathroom Fittings</b>	<p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.</p> <p>Mains supply of water and plumbing, where seen, is of PVC and copper design. A modern sink unit has been installed within the kitchen with the various bathroom and en-suite fittings being on mixed, predominantly modern lines.</p>

<b>Heating and Hot Water</b>	<p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.</p> <p>There is a full gas fired central heating system within the property with radiators located within the main apartments. The central heating piping is of mixed PVC and copper design with the majority of the radiators benefitting from individual thermostatic controls.</p> <p>Domestic hot water would appear to be provided via the central heating system with the boiler being of a wall mounted design located within the kitchen cupboard. We understand from the current owners that the boiler was replaced in 2022 and that the system is inspected and maintained on an annual basis.</p>

<b>Drainage</b>	<p>Drainage covers etc were not lifted.</p> <p>Neither drains nor drainage systems were tested.</p> <p>Drainage is assumed to be connected to the main drain.</p>

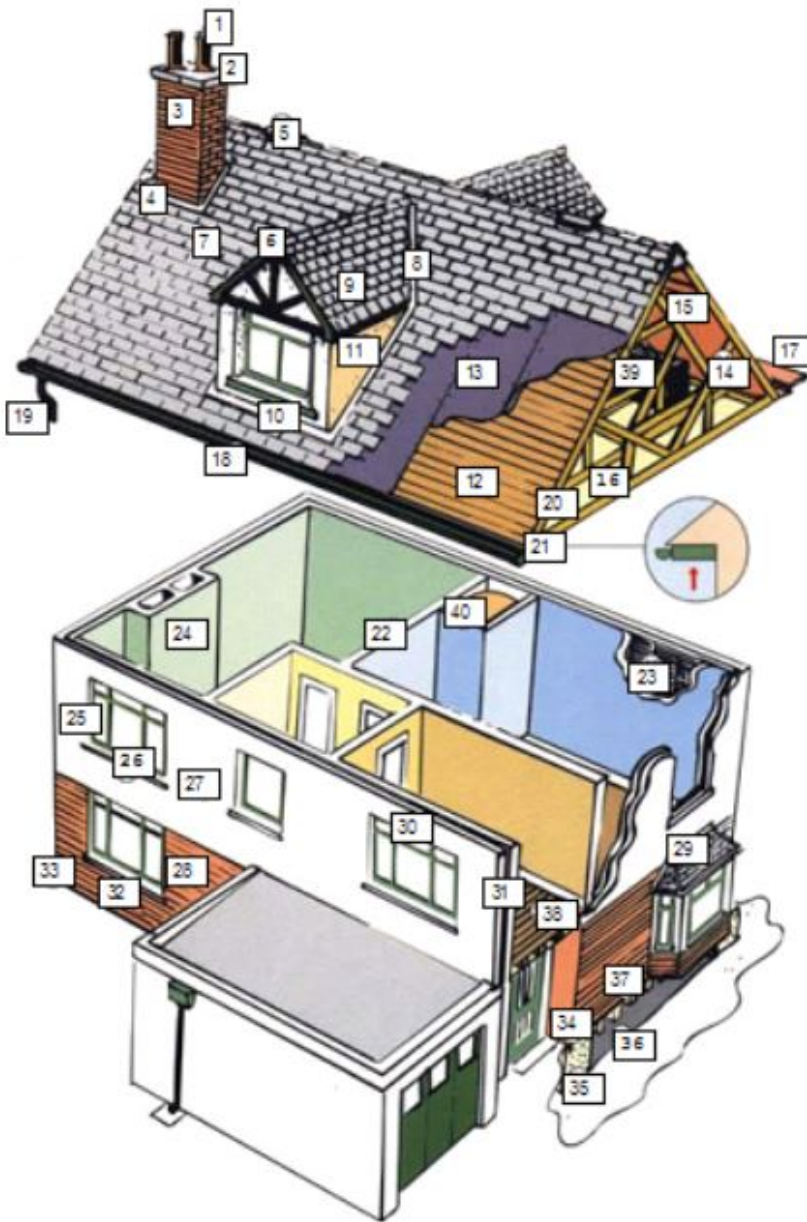
<b>Fire, Smoke and Burglar Alarms</b>	<p>Visually inspected.</p> <p>No tests whatsoever were carried out to the system or appliances.</p> <p>New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.</p> <p>There are smoke alarms fitted within the property.</p>

<b>Additional limits to Inspection</b>	<p>It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.</p> <p>No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.</p> <p>The inspection of the attic roof void was extremely limited and restricted to a head and shoulders inspection only.</p> <p>The property was fully furnished at the time of our inspection and the services were not tested.</p> <p>Due to fitted carpets and floor coverings no detailed inspection was possible of the floor timbers and accordingly we cannot guarantee their soundness or otherwise.</p> <p>It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.</p> <p>The inspection of the roof coverings, chimneys, metalwork, etc was extremely limited especially the roof coverings due to their design and neighbouring properties.</p> <p>Vegetation greatly restricted the inspection of various boundary walls.</p>

<b>Notes</b>	There is evidence of movement within the property, evident by a run in the flooring as well as cracking to the cornicing and externally cracking to the stonework. On the basis of a single inspection the movement would appear to be longstanding and non-progressive.


 Dampness, Rot and Infestation	
<b>Repair Category</b>	<b>2</b>
<b>Notes</b>	<p>Evidence of woodworm was noted within the attic roof void. It may well be the case that the woodworm is inactive or has been previously treated however this cannot be confirmed on the basis of a single inspection.</p> <p>Evidence of damp meter readings were also noted.</p> <p>An inspection has recently been carried out by Hamptons, a copy of their report should be obtained. We understand that the works identified have been carried out, a copy of the guarantee should be obtained and kept on file.</p>

<b>Repair Category</b>	2
Notes	From ground level only a very limited inspection was possible of the chimney stacks and flashings, however, where seen, some general weathering was noted to the stonework. Given the age of the property, ongoing maintenance and repairs should be anticipated.


	<b>Roofing including Roof Space</b>
<b>Repair Category</b>	2
Notes	<p>The roof coverings are of original design. Where seen from ground level, there are slipped and broken slates. Some sections were unable to be inspected and accordingly no comment can be made as to their condition.</p> <p>The roof covering is now of an age where ongoing and regular maintenance will be required and it would be prudent to seek the advice of a roofing contractor to comment on its current condition and expected lifespan.</p> <p>As stated previously, the inspection of the attic roof void was extremely limited.</p>


	<b>Rainwater Fittings</b>
<b>Repair Category</b>	2
Notes	<p>At the time of our inspection there was no evidence of damp staining/water staining on wall surfaces which would indicate leakage. It should be noted that it was not raining at the time of our inspection.</p> <p>There is however evidence of corrosion to cast iron sections. Ongoing maintenance, repair and eventual replacement should be anticipated. Regular inspections and maintenance to the valley gutters will be required. Some of the valley gutters, including the large centre valley, were unable to be inspected and accordingly no comment can be made as to their condition. It recommended that these are fully inspected to fully ascertain their current condition.</p>

	<b>Main Walls</b>
<b>Repair Category</b>	2


Notes	<p>The stonework would appear to be in a condition consistent with their type and age. There is evidence of some general weathering as well as cracking to the stonework. Ongoing maintenance and repair should be anticipated.</p> <p>The rear outshoot would appear to be of single brick design. This type of construction is prone to dampness. Ongoing maintenance and repair should be anticipated.</p>

	<b>Windows, External Doors and Joinery</b>
<b>Repair Category</b>	2
Notes	<p>The windows are of mixed design and age. Not all windows were checked or tested however the windows that were would appear to be in a condition consistent with their type and age. We understand from the current owner that an overhaul and maintenance programme has been carried out to the windows with various maintenance and repairs having been carried out. The extent of these works should be confirmed.</p> <p>Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/repair will be required as part of an ongoing maintenance programme.</p> <p>Double glazed windows may be prone to misting/interstitial condensation which can be more evident and can change in certain temperatures/weather conditions.</p>

Notes	<p>The external decorations are generally in /good order. Regular repainting will be required if these areas are to be maintained in satisfactory condition.</p>

	<b>Garages and Permanent Outbuildings</b>
<b>Repair Category</b>	2
<b>Notes</b>	<p>The garage would appear to be in a condition consistent with its type and age. There is evidence of some previous movement to the garage, this would appear to be historic and longstanding, based on a single inspection. The electrics are understood to have been upgraded, this will require to be confirmed. We understand that some maintenance/repairs have been carried out to the garage roof. The extent of these works will require to be confirmed. From a previous inspection evidence of woodworm was noted to timbers. It is assumed that the woodworm is inactive however this cannot be confirmed.</p> <p>Due to contents, the inspection of the garage was limited.</p>


	<b>Outside Areas and Boundaries</b>
<b>Repair Category</b>	2
<b>Notes</b>	<p>As stated previously, the inspection of the boundary walls was extremely limited due to vegetation. There is evidence however of weathering and open joints. Given the size and age of the boundaries, these should be inspected to ascertain current condition.</p> <p>There is evidence of some movement to boundaries. On the basis of a single inspection the movement would appear to be longstanding however this could not be confirmed on the basis of a single inspection some maintenance and repairs may well be required.</p>


	<b>Ceilings</b>
<b>Repair Category</b>	1

Notes	The ceilings are predominantly of the original timber lath and plaster. There is evidence of cracking and unevenness to ceilings which are of lath and plaster construction. The strength of this type of ceiling depends on how well the plaster keys into the lath.

	<b>Internal Walls</b>
<b>Repair Category</b>	<b>1</b>
Notes	The internal walls are largely covered with decorative finishes. During routine redecoration some plaster filling may be necessary.


	<b>Floors including Sub-Floors</b>
<b>Repair Category</b>	<b>1</b>
Notes	Fitted floor coverings greatly restricted the inspection of the flooring. No sub-floor inspection was made and accordingly no comment can be made as to the condition of timbers within this area.

	<b>Internal Joinery and Kitchen Fittings</b>
<b>Repair Category</b>	<b>1</b>
Notes	The internal joinery is generally in keeping with the age and type of property and appeared in good condition consistent with age.


	<b>Chimney Breasts and Fireplaces</b>
<b>Repair Category</b>	<b>1</b>
Notes	All flue linings should be checked, repaired if necessary and swept prior to the fires being reused.






	<b>Internal Decorations</b>
<b>Repair Category</b>	1
Notes	The property is generally in fresh decoration throughout.

	<b>Cellars</b>
<b>Repair Category</b>	-
Notes	Not applicable.

	<b>Electricity</b>
<b>Repair Category</b>	2
Notes	<p>We understand from the current owners that the property was inspected in 2022 and an Electrical Installation Condition Report prepared on the electrical system. All documentation should be obtained prior to purchase to confirm the condition of the system. As with many properties of this type and age, the electrical system would appear to be on mixed lines.</p> <p>The Institution of Engineering and Technology recommends that inspections and testing are undertaken at least every ten years and on a change of occupancy. It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.</p>

<b>Repair Category</b>	1
Notes	In the interest of safety all gas appliances should be checked by a Gas Safe Registered Engineer.





## Water, Plumbing and Bathroom Fittings

**Notes**

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

The plumbing and fittings appear of copper/PVC piping where seen and appeared in serviceable condition but was not tested.

The sanitary fittings appeared in fair order consistent with age.



## Heating and Hot Water

**Notes**

The central heating system, including radiators and pipework are of mixed design and age. The boiler has been replaced with the current owners informing us that these works were carried out in 2022. We also understand that annual inspection and maintenance have been carried out over the system. It may well be the case that there is still a guarantee over the boiler. Further information should be obtained.

The most recent maintenance report should be obtained prior to purchase to fully confirm current condition of the system. In line with our usual practice, if documentation is not available or not in order the system should be inspected to confirm condition.

It is recommended that where repairs, defects or maintenance items have been identified interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

Alterations have been carried out previously, these works would appear to have been carried out in excess of 20 years ago.

The applicant's legal adviser should ascertain liability for repair to the boundary walls.

The property is understood to be trading as a Bed & Breakfast establishment. For the purposes of this report we have given no consideration to trading value and the property has been valued as a residential premises.

We were informed by the current owner that the property is not listed or situated within a Conservation Area, this will require to be confirmed.

### Estimated Reinstatement Cost for Insurance Purposes

£960,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £960,000 (Nine Hundred and Sixty Thousand Pounds Sterling).

**Valuation and Market Comments****£475,000**

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £475,000 (Four Hundred and Seventy Five Thousand Pounds Sterling).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

### GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, **visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.**

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

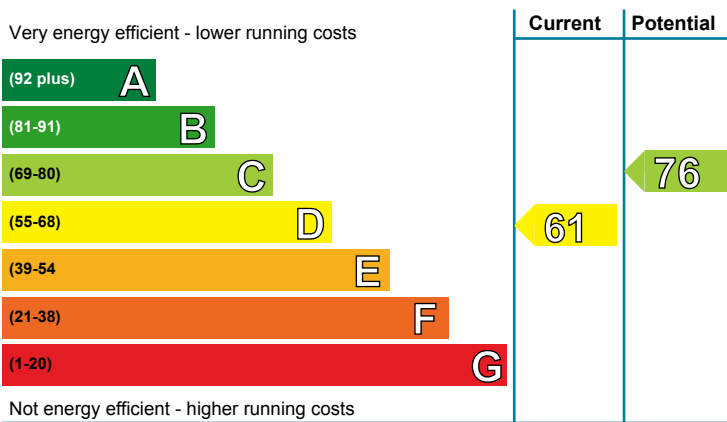

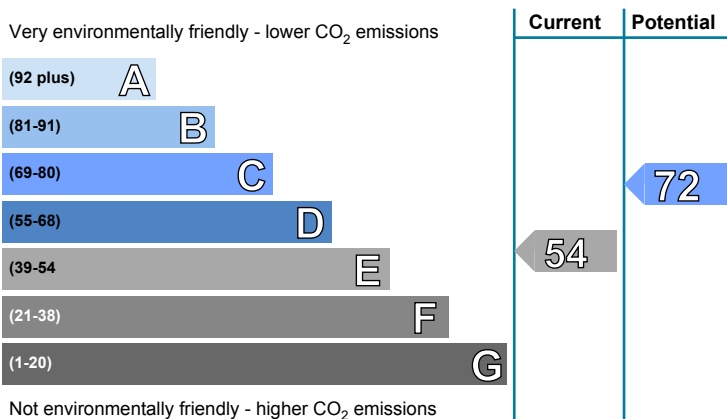

## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. ### 1 Internal wall insulation

Internal wall insulation involves adding a layer of insulation to the inside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. Thank you for inviting us to report on this property, the inspection of which was carried out by our surveyor Sandy Watson on 17<sup>th</sup> September 2025. In accordance with your instructions, we have confined our inspection to the under mentioned accessible areas. If there are any omissions or, if you believe that we have misunderstood your instructions please let us know without delay.

Our report and recommendations are set out below and should be read in conjunction with the attached specification.

The terms Left, Right, Front and Rear are used as if one is standing outside the building facing the front elevation.

All infestations referred to in this report are of Common Furniture Beetle **Anobium punctatum** unless otherwise stated.

## **PROPERTY DESCRIPTION: STONE BUILT SEMI DETACHED DWELLING HOUSE**

As instructed by yourself this survey was to Roof Void for Woodworm and Room Front Right for damp.

### **Roof Void**

Restricted inspection due to insulation materials and stored articles. Where seen, a slight scattered infestation of Woodworm was evident in roof timbers.

## **TREATMENT RECOMMENDED: FULL ROOF VOID TREATMENT**



Our technicians will carry out the necessary precautions prior to and during treatments i.e., protect all water tanks and electrical junction boxes with polythene. They will also remove all fuses appertaining to wiring within roof void prior to spraying (all as applicable).

Our technicians will lift and store insulation material in roof void and relay same after our treatments.

### **Room Front Right**

High moisture readings were obtained on right wall at blocked up chimney. In our opinion, this has been caused by water ingress due to a build-up of debris behind wall linings in chimney five. As discussed with yourself, your own contractor will clear out debris and install vent. Given time the wall should dry out naturally.

Please note that we feel it is important that there are various concealed timbers that that cannot be inspected during a normal survey of a property such as timber safe lintels, bonding timbers, wall framing and lath, wall plugs, "built in" joist ends and wall plate etc which are hidden by wall linings. We therefore cannot comment on any of these or any other concealed timbers at this time.

We respectfully draw your attention to the fact that during this pre-purchase survey the inspection was limited due to fitted floor coverings etc therefore, the inspection was limited accordingly. We cannot be held responsible for any defect other than those mentioned in this report. Nor can we be held responsible for any structural defects found. This type of defect should be pointed out to yourself by your own Surveyor.

Timbers will be treated using WYKAMOL Micro Insecticide/Dual Purpose which has been given a one-hour re-entry classification by The Health & Safety Executive.

Thank you for your verbal acceptance of our quotation. We will arrange to commence the work on 13<sup>th</sup> October 2025. Please confirm your acceptance of our quotation in writing (email is sufficient) prior to our start date.


