#### 1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

## Chimney Stacks Visually inspected with the aid of binoculars where appropriate. The chimney stack is of brick construction served with metal flashings.

#### **Roofing including Roof Space**

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.

Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

The roof is of pitched timber construction externally clad in interlocking concrete tiles with tiled ridging and cement skews. There is a tile clad projection to the front of the property and a flat roof to the rear which forms a balcony.

Access to the roof space is via an apex hatch within the upper landing. The roof space was found to be insulated over joists and this restricted our inspection to a head and shoulders type only. No access was gained to any eaves hatches due to furniture.

#### **Rainwater Fittings**

Visually inspected with the aid of binoculars where appropriate.

The rainwater goods are of PVC design.

#### Main Walls

Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.

The main walls are of cavity brick construction externally roughcast incorporating facing brick features. Cavity wall insulation appears to have been injected into the wall cavity, reflected by external drill holes, although we would confirm that no documentation in this regard has been viewed.

## Windows, External Doors and Joinery Internal and external doors were opened and closed where keys were available. Random windows were opened and closed where possible. Doors and windows were not forced open. The windows are of a mixed age uPVC coated aluminium and uPVC double glazed design. Access to the property is via an aluminium and glazed front entry door and a uPVC and glazed side entry door. There are aluminium and double glazed patio doors within the lounge which give access to the rear garden. A uPVC and glazed door gives access to the balcony.

The balcony is enclosed with a metal framed and sheeted balustrade.

Outbuildings	There is a single garage located on site. This is of brick construction externally roughcast with a corrugated cement fibre roof covering over. Attached to this is a car port constructed between the gable wall and the boundary of the property. The roof over this part is also laid in corrugated cement fibre. The garage is served with a manual up-and-over door.  Outbuildings comprise a timber and felt garden shed.

#### **Outside Areas and Boundaries**

Visually inspected.

There are areas of private garden ground to the front and rear of the property and off street parking is provided on a private drive. The grounds are predominantly laid to lawn and incorporate paving slabs and stone chipped areas. The site is part open to the front and boundaries comprise timber fencing, hedging and masonry walls which are externally roughcast.

#### Ceilings

Visually inspected from floor level.

The ceilings appear to be of plasterboard design throughout.

#### **Internal Walls**

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

The internal walls are of brick construction plastered on the hard and timber stud overlaid in plasterboard.

#### Floors Including Sub-Floors

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.

Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so, and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.

The flooring within is of suspended timber construction. Floors were fully covered and no access was gained to any sub-floor chambers.

### Water, Plumbing and Bathroom Fittings

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Mains supply of water. There is a sink unit in the kitchen and the plumbing, where viewed, is of PVC and copper design.

The bathroom fittings at ground floor level have been upgraded to a modern style and type and comprise a WC, wash-hand basin and plumbed-in shower over bath. The en-suite shower room fittings are along older lines and comprise a WC, wash-hand basin and electric shower in cubicle.

#### **Heating and Hot Water**

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Space heating is by means of a gas fired system. There is a Worcester Greenstar condensing combination boiler located within an upper bedroom cupboard and this feeds wall mounted radiators. The central heating system appears to provide domestic hot water.

#### **Drainage**

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

Presumed to be connected to the main public sewer.

#### Fire, Smoke and Burglar Alarms

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

#### **Additional limits to Inspection**

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

Insulation has been laid over the roof joists and accordingly a head and shoulders inspection of the roof space was possible only. No access was gained to any eaves areas due to furniture.

It should be appreciated that the Home Report inspection is a nondisruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

Notes	The roof covering appears original and is weathered and moss covered and there is evidence of cracking to cement skews. The roof covering is now of an age where ongoing and regular maintenance will be required and it would be prudent to seek the advice of a roofing contractor to comment on its current condition and expected lifespan.
	The balcony is formed with a flat felt roof and this is typically weathered. It should be appreciated that flat roofs have a limited life and require ongoing maintenance. Any information as to its last renewal should be obtained, if available.

Notes	At the time of our inspection there was no evidence of damp staining/water staining on wall surfaces which would indicate leakage. It should be noted that it was not raining at the time of our inspection.

Notes	The main walls appear in fair order consistent with age. Past patching repairs appear to have been carried out to areas of roughcast. Areas of staining were noted at points.

	Windows, External Doors and Joinery

# Notes The windows have been partially upgraded to a modern style and type, although older aluminium units remain. These are affected by stiff mechanisms/ironmongery. Ongoing maintenance will be required and eventual upgrading should be anticipated. Windows can be problematic and over time the operation of the windows can be affected and opening mechanisms damaged. It is therefore likely that maintenance/ repair will be required as part of an ongoing maintenance programme. Double glazed windows may be prone to misting/interstitial condensation which can be more evident and can change in certain temperatures/weather conditions. The balustrade of the balcony is formed by metal and sheeted railings and the sheets appear to be of asbestos cement design. The current informed view is that if left undisturbed this will present no significant hazard to health unless cut or sanded, resulting in dust within the air. The metalwork of the balustrade of the balcony is affected by corrosion.

	Garages and Permanent Outbuildings

Notes	Extensive repairs are required to the garage. Areas of cracked and bossed roughcast were noted and a window is boarded up. Repairs to the roof covering over the garage and car port should be envisaged as part of a repair/maintenance programme as these appear to be laid in corrugated asbestos. The current informed view is that if left undisturbed this will present no significant hazard to health. However, some potential purchasers may be deterred by its presence and in the event of damage or disturbance higher than average costs should be anticipated in respect of removal and handling. This should be carried out by a specialist contractor.

	Outside Areas and Boundaries

Notes	The outside areas appear well maintained. We understand the timber fencing has recently been installed and an area is yet to be completed. The masonry walls to the side are affected by missing roughcast, damaged/exposed brickwork and general weathering/deterioration. Some rebuilding repairs should be anticipated.  You should verify with your conveyancer the extent of the boundaries attaching to the property.

Notes	The consumer unit has been upgraded in the past although the wiring throughout appears to be along mixed lines. The Institution of Engineering and Technology recommends that inspections and testing are undertaken at least every ten years and on a change of occupancy. It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.

## Notes The plumbing and fittings appear of copper/PVC piping where seen and appeared in serviceable condition but was not tested. The en-suite shower room fittings are along older lines. Waterproof seals were found to be slightly worn and it is recommended that these be repaired. Slightly elevated damp meter readings were taken adjacent to the shower tray. It is recommended that this area be further investigated. The ground floor bathroom fittings have been upgraded to a modern style and type. We noted no defects. It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Restricted parking includes parking that is subject to parking restrictions, as indicated by the presence of solid yellow, red or white lines at the edge of the road or by a parking control sign, parking meters or other coinoperated machines.

#### 4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

#### Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

Layout alterations have been carried out whereby a partition between the former kitchen and dining room has been removed to form open plan accommodation. The original kitchen door has also been blocked up. We understand these works fell within permitted development, although we have made no enquiries in this regard. This should be confirmed.

#### **Estimated Reinstatement Cost for Insurance Purposes**

£330,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £330,000 (THREE HUNDRED AND THIRTY THOUSAND POUNDS STERLING).

#### Valuation and Market Comments

£315,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £315,000 (THREE HUNDRED AND FIFTEEN THOUSAND POUNDS STERLING).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

#### TERMS AND CONDITIONS OF SINGLE SURVEY GENERAL

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. #### 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

#### 1.3 Liability

The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

The Report is addressed to the Seller and is prepared in the expectation that it (or a complete copy) along with these Terms and Conditions (or a complete copy) would be (or, as the case might be, would have been) disclosed and delivered to:

- the Seller
- any person(s) noting an interest in purchasing the Property from the Seller;
- any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- the Purchaser; and
- the professional advisors of any of these.



The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

Graham + Sibbald's total liability to the Client (and any third party relying upon this report) under this Agreement (including liability in contract, tort (including negligence), breach of statutory duty, or otherwise) shall be limited to the lower of the following: a) 25% of the valuation or b) £250,000.

#### **DESCRIPTION OF THE REPORT**

#### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

#### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

#### 2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

#### 2.3.1 Category 3:





#### The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. #### The impact of your home on the environment



#### About the recommended measures to improve your home's performance rating

#### 1 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. #### 2 Low energy lighting

Replacement of traditional light bulbs with energy saving bulbs will reduce lighting costs over the lifetime of the bulb, and they last many times longer than ordinary light bulbs. Low energy lamps and fittings are now commonplace and readily available. #### 3 Heating controls (room thermostat)

The heating system should have a room thermostat to enable the boiler to switch off when no heat is required. A competent heating engineer should be asked to do this work. Insist that the thermostat switches off the boiler as well as the pump and that the thermostatic radiator valve is removed from any radiator in the same room as the thermostat. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

#### 4 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). #### Low and zero carbon energy sources
