Carmarthen is the home to a large number of administrative offices including Carmarthenshire County Council and Dyfed Powys Police Headquarters. The university of Trinity St David has a large presence in the town which also is home to Glangwili General Hospital. It is also a centre for regional offices for many private sector firms who need a base in West Wales.
