Location

Chelmsford is located approximately 37 miles north east of London and benefits from excellent communications via the A12 giving direct access to the M25 (Junction 28) within 12 miles. The M11 and Stansted Airport are also easily accessible. The City's railway station is within 0.4 miles and provides a fast and frequent service to London Liverpool Street with journey times from approximately 32 minutes.

The property is situated on Hall Street at its junction with Roman Road. Moulsham Street, and Chelmsford High Street are a short walk, and provides city centre retail, restaurant and leisure facilities.

Description

The property comprises a single storey brick built church beneath a pitched tile roof constructed in 1863 and extended in 1899 with further extensions added in later years to provide ancillary accommodation. Additionally to the side there is a gated Yard, plus storage building.

The accommodation provides a church, hall, store, kitchen and WC facilities and extends to approximately 205.41 sq m (2,211 sq ft) and storage building associated with the Builders Yard of approximately 11.36 sq m (122 sq ft).

The property sits on a site of approximately 0.0.36 hectares (0.09 acres).
