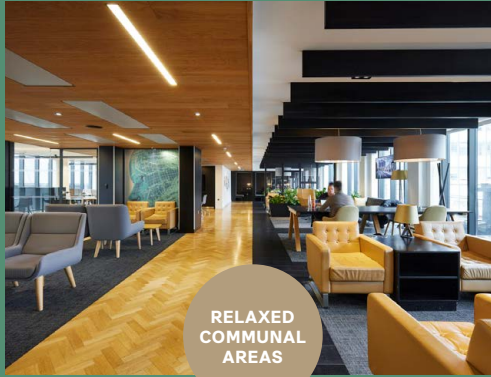

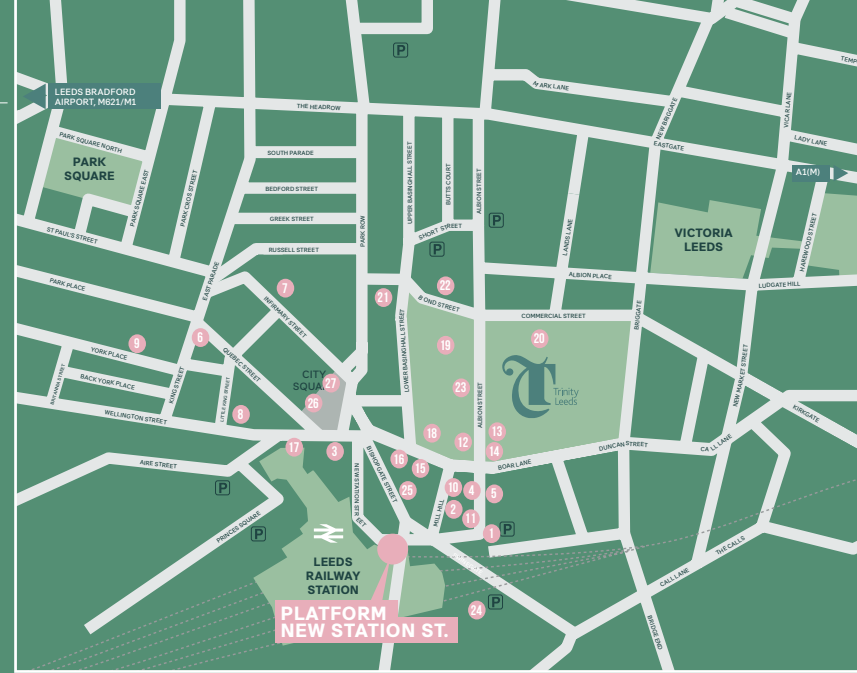
The perfect office suite surrounded by activity.
