The entrance hall has laminate flooring, carpeted stairs with a glass balustrade, two radiators, two built-in cupboards and a single composite door providing access into the accommodation.

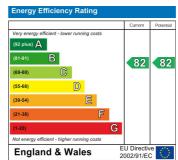

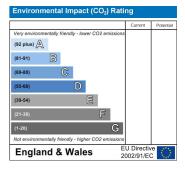
