The land is located to the west of the village of Kirkby Fleetham, approximately 9 miles from the city centre of Northallerton.

The proposed site is bordered to the north and west by open countryside, residential properties to the east and Lumley Lane to the south.

#### **PLANNING MATTERS**

The site has outline planning consent (21/00582/OUT), for the erection of 5 dwellings with access and layout considered, the indicative total floor area being 11,500sqft. Access is taken directly off the public highway, Lumley Lane.

The design principle is that of a former farmstead, with a farmhouse, a pair of cottages and two converted barns, mimicking those seen throughout the district.


