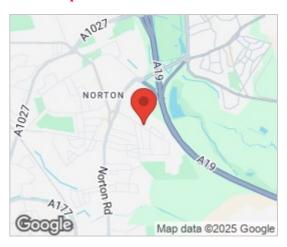

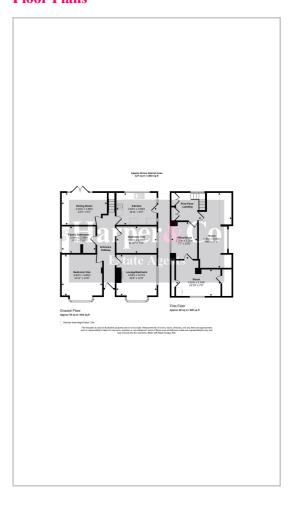

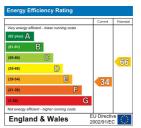
Area Map

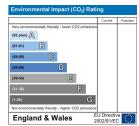


Floor Plans
