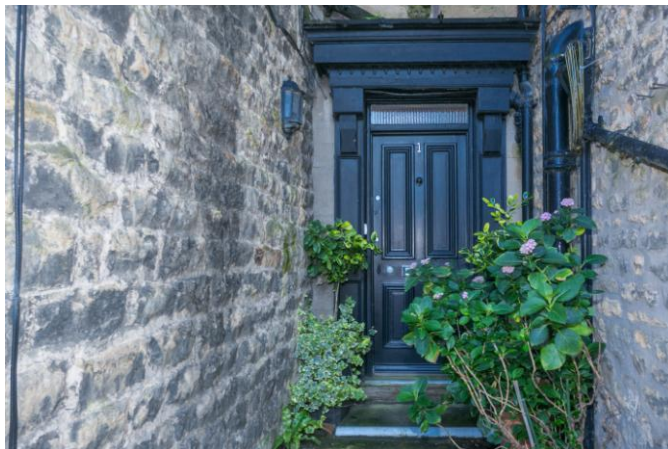

A Grade II listed three storey, four bedroom, centrally heated, town house, situated within this ancient market town's conservation area. Accommodation on the ground floor includes sitting room, (note multi-fuel stove not included), an open plan fitted kitchen/dining area and reception room (note stove not included), rear entrance and cloakroom. On the first floor there is a well proportioned double bedroom, house bathroom, bedroom 2 with staircase to the second floor. On the second floor are two further double bedrooms.

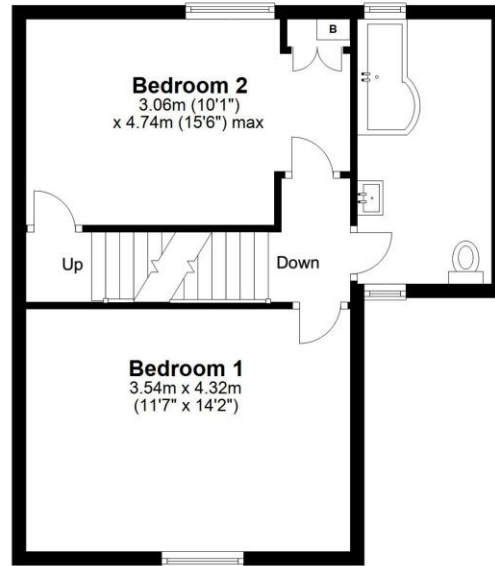
Externally there is a rear cottage garden, with two storey brick building, which could lend itself to further accommodation subject to the appropriate consents.

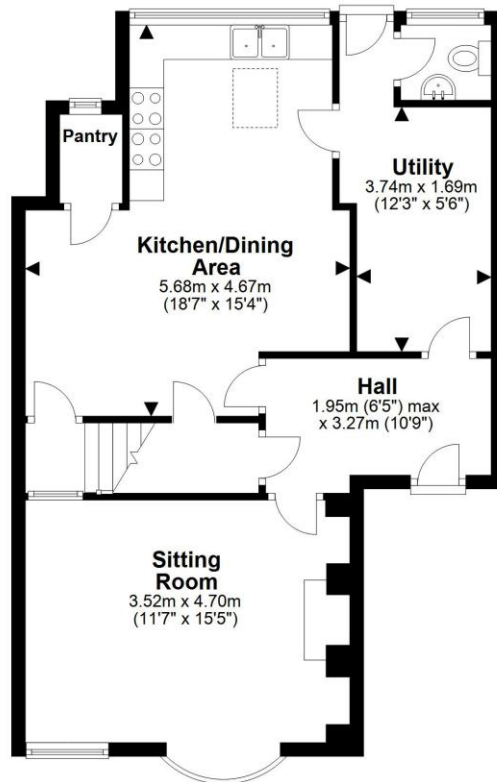
First Floor

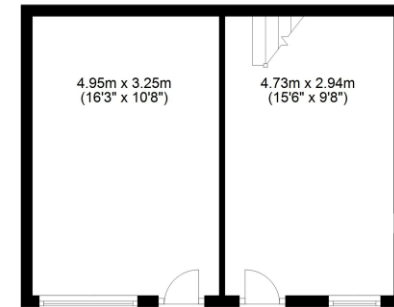
Ground Floor

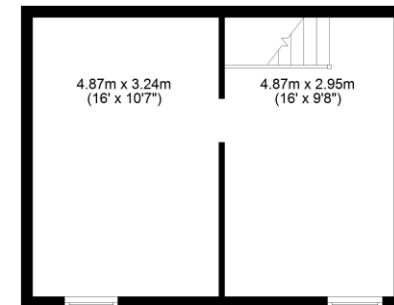
Ground Floor

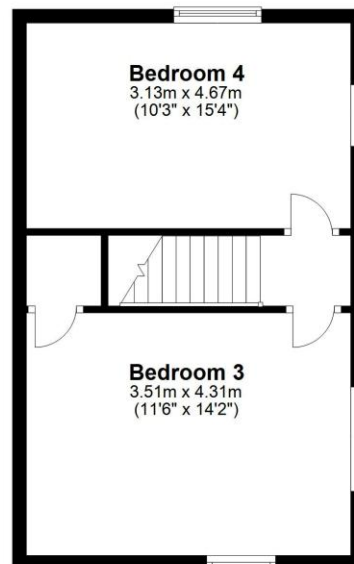
First Floor
