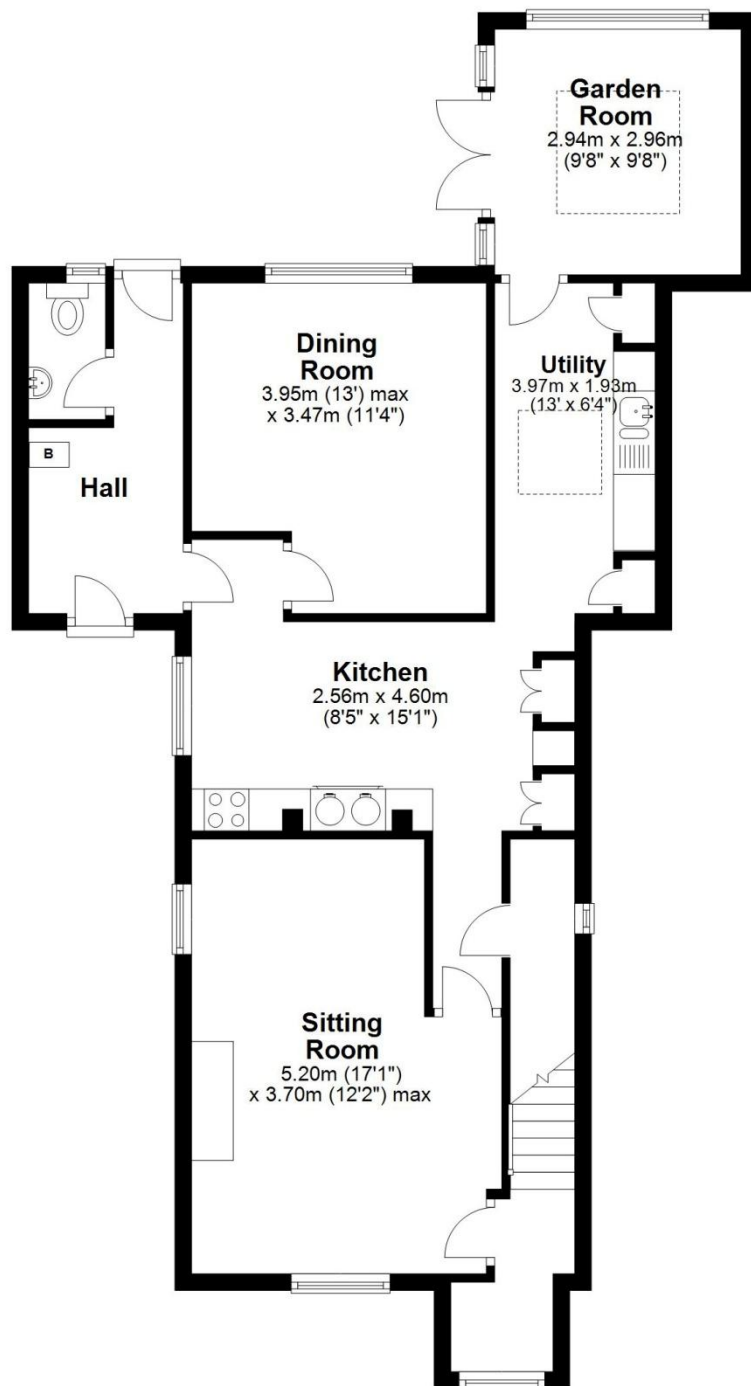

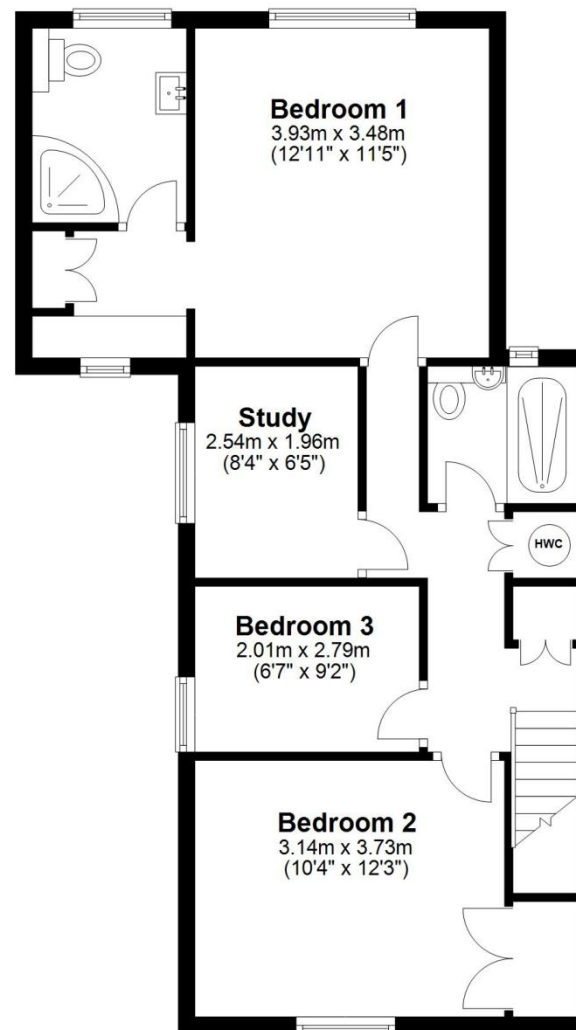
Ground Floor

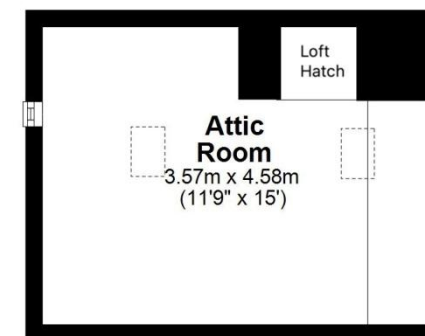
First Floor
