LOCATION

Newburn Haugh Industrial Estate is located off Riversdale Way, immediately south of Lemington Road in Newburn, Newcastle upon Tyne. The estate benefits from close proximity to the A6085 trunk road, providing access to the A1(M) approximately 0.9 miles to the east allowing for vehicular access to the wider regions road network.

The estate lies south of Lemington, with the established Newburn Riverside and Gateway mixed use development a short distance south of the subject.

DESCRIPTION

The estate comprises terraced industrial units of steel portal frame construction.

The external elevations are of insulated profile metal cladding (above brick to the front elevation) under a pitched roof. Internally the units are to be refurbished, but currently comprises concrete flooring, strip lighting, translucent roof panels to roof and one electrically operated roller shutter door.

Each property benefits from assigned car parking spaces.

Each unit benefits from W/C access.

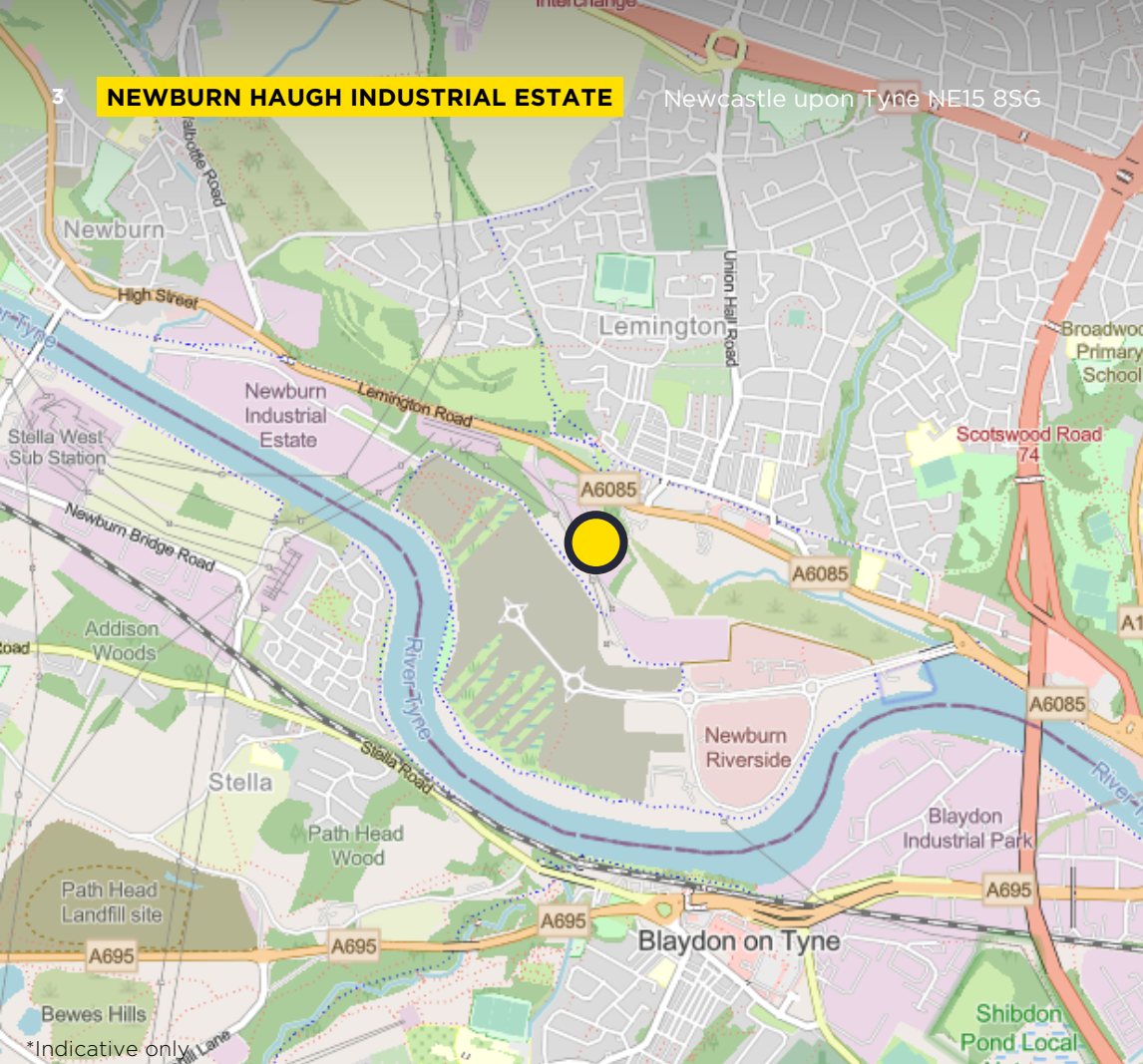
